THE ANTIQUITIES ORDINANCE
(Ordinances 12 of 1975 and 7 of 1981).

**ORDER BY THE ADMINISTRATOR UNDER PARAGRAPH (a)
OF SUBSECTION (1) OF SECTION 6.**

In exercise of the powers conferred upon him by paragraph (a) of subsection (1) of Section 6 of the Antiquities Ordinance, 1975 the Administrator, after consultation with the appropriate authorities of the Republic, hereby declares the buildings and sites set out in the Appendix hereto, to be ancient monuments and further declares that such monuments shall be added to the Second Schedule to the Ordinance.

AUTHORISATION UNDER SECTION 9.

- (b) the words "Unnamed road leading from Xylotymbou Police Station" substituting therefor the words "Steliou Kyriakide Street."

AUTHORISATION UNDER SECTION 9.

In exercise of the powers conferred upon me by Section 9 of the Public Roads (Protection) Ordinance and of all other powers enabling me in that behalf, I the Chief Officer, Sovereign Base Areas, hereby amend the Schedule to Public Instrument No.21 of 1986 as follows:-

In Part II "Dhekelia Area" by deleting from Column I thereof -

- (a) the words "Unnamed road from the north-west of Xylotymbou village" substituting therefor the words "Archiepiskopou Kyprianou Street";
- (b) the words "Unnamed road from the north-east of Xylotymbou village" substituting therefor the words "Louki Akrita Street";
and
- (c) the words "Xylotymbou Road (North)" substituting therefor the words "Leoforos Archiepiskopou Makariou III North".

(Ordinances 11 of 1962, 9 of 1963, 3 of 1967, 10 of 1972
and 10 of 1982).

**CONTROL AND MAXIMUM PRICE ORDER MADE
UNDER SECTIONS 3(1) AND 4(1).**

In exercise of the powers vested in him by subsection (1) of Sections 3 and 4 of the Commodities and Services (Regulation and Control) Ordinance, the Administrator hereby makes the following Order:-

1. This Order may be cited as the Commodities and Services (Regulation and Control) (Maximum Price of EDAM Cheese) Order, 1994.
2. Locally produced Edam cheese is hereby declared to be a controlled commodity for the purpose of this Ordinance.
3. The prices at which locally produced cheese of the EDAM type sold in the Areas shall not exceed the maximum wholesale and retail prices set out in the second and third columns respectively of the Schedule hereto.
4. Public Instrument No. 46 of 1993 is hereby revoked.

(Ordinances 11 of 1962, 9 of 1963, 3 of 1967, 10 of 1972
and 10 of 1982).

**CONTROL AND MAXIMUM PRICE ORDER MADE
UNDER SECTIONS 3 (1) AND 4 (1).**

In exercise of the powers vested in him by subsection (1) of Sections 3 and 4 of the Commodities and Services (Regulation and Control) Ordinance, 1962 the Administrator hereby makes the following Order:-

1. This Order may be cited as the Commodities and Services (Regulation and Control) (Maximum Price of Potatoes) (Amendment) Order, 1994 and shall be read as one with the Commodities and Services (Regulation and Control) (Maximum Price of Potatoes) Order, 1975 as amended from time to time (hereinafter referred to as "the principal Order").

2. The principal Order is hereby amended by deleting the Schedule thereto and substituting therefor the following new Schedule:-

**"SCHEDULE
Fixed Maximum Prices.**

First Column	Second Column	Third Column
Description of controlled commodity	Maximum wholesale price	Maximum retail price
Potatoes :	£ 0,21 per kilogram	£ 0,25 per kilogram

3. (i) Provided that where the maximum wholesale price of potatoes falls below £0,21 cents per kilogram, the maximum retail price shall be their wholesale purchase price, as this shall be verified from the invoice issued by the producer or the wholesaler, plus £0,04 per kilogram;
- (ii) provided further that the maximum wholesale and retail prices of potatoes shall be released from control, from the 15th September to the 15th November every year.
