THE PUBLIC ROADS (PROTECTION) ORDINANCE
(Cap.83 - Laws of Cyprus and Ordinance 27 of 1961).

AUTHORISATION UNDER SECTION 9.

In exercise of the powers conferred upon me by Section 9 of the Public Roads (Protection) Ordinance and of all other powers enabling me in that behalf, I, the Chief Officer, Sovereign Base Areas, hereby amend the Schedule to Public Instrument No.19 of 1986 as follows:-

In Part V "Dhekelia Area" by adding the following particulars in Columns 1 and 2 thereof:-

**THE COMMODITIES AND SERVICES (REGULATION
AND CONTROL) ORDINANCE**

(Ordinances 11 of 1962, 9 of 1963, 3 of 1967, 10 of 1972
and 10 of 1982).

**CONTROL AND MAXIMUM PRICE ORDER MADE
UNDER SECTIONS 3 (1) AND 4 (1).**

In exercise of the powers vested in him by subsection (1) of Sections 3 and 4 of the Commodities and Services (Regulation and Control) Ordinance, 1962 the Administrator hereby makes the following Order:-

1. This Order may be cited as the Commodities and Services (Regulation and Control) (Maximum Price of Potatoes) (Amendment) (No.2) Order, 1994 and shall be read as one with the Commodities and Services (Regulation and Control) (Maximum Price of Potatoes) Order, 1975 as amended from time to time (hereinafter referred to as "the principal Order").

2.The principal Order is hereby amended by deleting the Schedule thereto and substituting therefor the following new Schedule:-

**"SCHEDULE
Fixed Maximum Prices.**

First Column	Second Column	Third Column
Description of controlled commodity	Maximum wholesale price	Maximum retail price
Potatoes :	£ 0,21 per kilogram	£ 0,25 per kilogram

3. (i) Provided that where the maximum wholesale price of potatoes falls below £0,21 cents per kilogram, the maximum retail price shall be their wholesale purchase price, as this shall be verified from the invoice issued by the producer or the wholesaler, plus 20% calculated on the wholesale price;
- (ii) provided further that the maximum wholesale prices of potatoes shall be released from control during the period from the 15th September to the 15th November every year;
- (iii) provided further that during the period from 15 September to 15 November, the maximum retail price of potatoes shall be their wholesale purchase price, as this shall be verified from the invoice issued by the producer or the wholesaler, plus a percentage of 20% calculated on the wholesale price.

4. For imported potatoes, the maximum percentage of combined profit for wholesale and retail sale shall be as follows:-

First Column	Second Column	Third Column
Description of controlled commodity	Maximum percentage of combined profit of the importer and the wholesaler calculated on the importer's warehouse costs	Maximum percentage of a retailer's combined profit calculated on the wholesale price as this is shown on the invoice.
Potatoes :	20%	20%
