No. 44**THE MOTOR VEHICLES AND ROAD
TRAFFIC ORDINANCE****(ORDINANCE 8 of 1973, 5 of 1982, 2 of 1983 and 11 of 1985)****ORDER UNDER SUB-SECTION (2) OF SECTION 4**

In exercise of the powers conferred upon me by sub-section (2) of Section 4 of the Motor Vehicles and Road Traffic Ordinance 1973, I, the Chief Officer, hereby make the following Order:-

1. This Order may be cited as the Speed Limits (Amendment) Order 1995 and shall be read as one with the Speed Limits Order 1989 (hereinafter referred to as 'the principal Order').

2. Paragraph (1) of Part II of the Schedule to the principal Order relating to the Larnaca - Famagusta Road is hereby amended by inserting under Columns 1 and 2 thereof the following particulars :-

"From a point approximately 200 yards south-west to a point approximately 200 yards north-east of Alexander Barracks roundabout, 50"

AUTHORIZATION UNDER SECTION 9

In exercise of the powers conferred upon me by Section 9 of the Public Roads (Protection) Ordinance and of all other powers enabling me in that behalf, I, the Chief Officer Sovereign Base Areas, hereby amend the schedule to Public Instrument No 20 of 1986 as follows:-

In Part II DHEKELIA AREA by adding the following particulars in Columns 1, 2 and 3 at the end thereof :-

A point on the Dhekelia / Xylophagou road 150 yards to the west from the western end of the Southern Conveyor Offices fence.	West to East	A point on the Dhekelia / Xylophagou road 150 yards to the east from the eastern end of the Southern Conveyor Offices fence.
