**THE MOTOR VEHICLES AND ROAD
TRAFFIC ORDINANCE**
(ORDINANCE 8 of 1973, 5 of 1982, 2 of 1983 and 11 of 1985)

ORDER UNDER SUB-SECTION (2) OF SECTION 4

In exercise of the powers conferred upon me by subsection (2) of Section 4 of the Motor Vehicles and Road Traffic Ordinance 1973, I, the Chief Officer, hereby make the following Order:-

1. This Order may be cited as the Speed Limits (Amendment) Order, 1995 and shall be read as one with the Speed Limits Order, 1989 (hereinafter referred to as 'the principal Order').

2. Paragraph (1) of Part II of the Schedule to the principal Order is hereby amended to read as follows:

**NOTICE UNDER SECTION 17 OF THE ANTIQUITIES ORDINANCE
AND SECTIONS 2, 3 AND 5 OF THE LAND ACQUISITION ORDINANCE**

Whereas it has been represented to the Administrator that it is desirable for the Crown to acquire certain land within that part of Pyla village lying within the Dhekelia Sovereign Base Area, for the purpose of archaeological excavations.

And whereas the Administrator has been satisfied that the aforesaid excavations must be carried out for public purposes.

Now, therefore, in exercise of the powers vested in him by Sections 2, 3 and 5 of the Land Acquisition Ordinance, the Administrator does hereby declare that the carrying out of the said excavations to be an undertaking of public utility and does hereby entrust the acquisition of the land required for the said undertaking to the Chief Officer, Sovereign Base Areas.

NOTICE UNDER SECTION 6.

With reference to Public Instrument No. 66 of 1995 published in Supplement No. 3 to the Gazette No. 1062 of the 18th October, 1995, notice is hereby given that the following land is required for the undertaking of public utility mentioned therein:-

The private immovable property within that part of Pyla village lying within the Dhekelia Sovereign Base Area under and in connection with Plot No. 121/2/1/1 of the Government Survey Plan XLI 19.

2. The land area of the above immovable property comprises 8 decars and 696 square metres or thereabouts and is shown coloured red on the relative plan signed by the Area Officer, Dhekelia, and dated 29 September, 1995.

Any person claiming to have any right or interest in the said land, who objects to the acquisition, is required within six weeks from the date of publication of this notice, to send to me a statement of his right and interest and of the evidence thereof and of any claim made by him in respect of such right or interest.

4. The Administrator is willing to treat for the acquisition of the said land.

**THE POWERS AND DUTIES (OFFICERS OF THE REPUBLIC
OF CYPRUS) (CONSOLIDATION) ORDINANCE, 1976**
(Ordinance 4 of 1976).

ORDER MADE BY THE ADMINISTRATOR UNDER SECTION 3.

In exercise of the powers conferred upon him by Section 3 of the Powers and Duties (Officers of the Republic of Cyprus) (Consolidation) Ordinance, 1976 and all other powers enabling him in that behalf, the Administrator hereby makes the following Order:-
