THE CORONERS ORDINANCE
(Ordinance 21 of 1989)

NOTICE UNDER SECTION 3(2)

**THE MOTOR VEHICLES
(THIRD PARTY INSURANCE) ORDINANCE**

(Cap.333 and 7 of 1960 - Laws of Cyprus - and Ordinances 5 of 1966, 15 of 1987, 8 of 1988, 18 of 1989, 5 of 1993 and 1 of 1995).

**ORDER MADE BY THE ADMINISTRATOR UNDER
SECTION 2.**

In exercise of the powers vested in him by Section 2 of the Motor Vehicles (Third Party Insurance) Ordinance, the Administrator hereby makes the following Order:-

1. This Order may be cited as the Motor Vehicles (Third Party Insurers) (Consolidation) (Amendment) Order, 1997 and shall be read as one with the Motor Vehicles (Third Party Insurers) (Consolidation) Order, 1994 (hereinafter referred to as "the principal Order").

2. Paragraph 2 of the principal Order is hereby amended by inserting in the appropriate alphabetical order the following new Insurance Company:-

"Royal Exchange Assurance".
