THE POLICE ORDINANCE

(Ordinances 9 of 1967, 14 of 1969, 7 of 1975 and 2 of 1993)

ORDER MADE UNDER SECTION 23(1)

---

In exercise of the powers vested in me by section 23(1) of the Police Ordinance, I, the Chief Constable, hereby order that the Kolossi-Akrotiri road from the "Y" junction outside the village to the main piquet post, RAF Akrotiri, shall be closed to all vehicular traffic from 0700 hours on Monday 23.2.98 until 1600 hours on Saturday 28.2.98. During this period vehicular traffic travelling on the above road will be diverted along a track road through the Sovereign Base Area.

**THE MOTOR VEHICLES AND ROAD TRAFFIC ORDINANCE**  
(Ordinances 8 of 1973, 5 of 1982, 2 of 1983 and 11 of 1985).

**REGULATIONS MADE UNDER SECTION 3(g).**

In exercise of the powers vested in him by paragraph (g) of section 3 of the Motor Vehicles and Road Traffic Ordinance 1973, the Administrator hereby makes the following Regulations:-

1. These Regulations may be cited as the Motor Vehicles (One-Way Traffic) Regulations 1998 and shall be read as one with the Motor Vehicles (One-Way Traffic) Regulations, 1986 as amended from time to time (hereinafter referred to as "the principal Regulations").

and 35/95.

2. The principal Regulations are hereby amended by the addition in Columns 1 and 2 respectively in Part I of the Schedule "AKROTIRI AREA", of the following:

Column 1	Column 2
Junction of M1 with Kolossi Akrotiri road to Asomatos Junction.	Anticlockwise.
Junction of Asomatos with Kolossi Akrotiri road towards Asomatos village.	Anticlockwise.

3. These Regulations shall come into force at 0900 hours on Sunday 22 February 1998 and shall cease to have effect at 1200 on the said date.
