## THE LAND ACQUISITION ORDINANCE

(Cap.226 - Laws of Cyprus - and Ordinances 12 of 1963,  
9 of 1964, 1 of 1986, 4 of 1987, 19 of 1988 and 10 of 1993).

**NOTICE UNDER SECTIONS 2,3 AND 5.**

---

Whereas it has been represented to the Administrator that it is desirable to construct public roads outside the affected area of the Agricultural Land Consolidation area in the villages of Ypsonas and Kolossi in the Sovereign Base Area of Akrotiri;

And whereas it is, in the opinion of the Administrator desirable, for public purposes, to construct the roads as aforesaid;

Now therefore, in exercise of the powers vested in him by sections 2, 3 and 5 of the Land Acquisition Ordinance, the Administrator does hereby declare the construction of the aforesaid roads to be an undertaking of public utility and does hereby entrust the acquisition of the land required for the said undertaking to the Chief Officer, Sovereign Base Areas.

## THE BOMBARDMENT RANGE AREAS ORDINANCE

(Cap. 213 - Laws of Cyprus).

**NOTICE UNDER SECTION 2.**

In exercise of the powers vested in him by section 2 of the Bombardment Range Areas Ordinance, the Administrator hereby declares the areas set out in the Schedule to this Notice to be a Bombardment Range Area for use by Her Majesty's Forces, until further notice, as practice areas for the purposes specified in the said section.

2. Public Instruments Nos. 19 of 1994 and 28 of 1994 are hereby revoked.

**SCHEDULE****The Pyla Bombardment Range Area.**

(1) *Sea Danger Area*:- That area of the territorial waters of the Sovereign Base Areas contained inside a line drawn through the following positions on Admiralty Chart No. 851 of 8th August 1941:-

**THE CONTROL OF WATER POLLUTION ORDINANCE 1998**  
(Ordinance 7 of 1998)

**ORDER MADE UNDER SECTION 6(1)**

In exercise of the powers vested in him by section 6(1) of the Control of Water Pollution Ordinance 1998 the Chief Officer hereby makes the following Order:-

1. This Order may be cited as the Control of Water Pollution (Measures for the Protection of the Surface and Underground Waters of "Symvoulos Dam" and its Immediate Replenishment Area) Order 1998.

2. In this Order, unless the context otherwise requires -

"Dam" means the Symvoulos Dam;

"Ordinance" means the Control of Water Pollution Ordinance 1998 and any subsequent Ordinance amending or substituted for the same;

"replenishment area" means the area from which it is considered that water may flow directly into the Dam, as indicated in red on Plan No. SBA 1/98 which forms part of this Order;

"surface water" means the water of the Dam and includes all areas which may be covered by such water when the Dam reaches its maximum capacity.

3. Subject to section 5 of the Ordinance any direct or indirect disposal or discharge of any of the substances referred to in Tables 1a and 1b of the Schedule to this Order into the surface water area or onto or into the ground or underground of the replenishment area is hereby prohibited.

4.-(1) Subject to section 5 of the Ordinance the dumping, placement, disposal or discharge anywhere in the replenishment area of any refuse, waste or litter which may cause pollution of the surface water of the Dam or of the underground water or any other form of pollution is hereby prohibited.

(2) Where any such refuse, waste or litter has been discharged in the replenishment area, the Chief Officer may serve on the person responsible a notice requiring him to remove the offending substance within seven days of the date of such notice.

(3) Where a person refuses or fails to take the steps referred to in the preceding paragraph such action may instead be taken by the Chief Officer and any costs occasioned thereby may be recovered as a civil debt from such person.

5.-(1) Subject to section 5 of the Ordinance, the discharge, disposal or effusion into bore-holes or wells within the replenishment area of any substance which may cause pollution to the waters of the Dam or any other form of pollution is hereby prohibited. Any person ceasing to use any well or bore-hole shall notify the Chief Officer within twenty one days of his ceasing such use and the Chief Officer may require such measures to be taken as he may deem expedient for the purpose of preventing pollution of the waters of the Dam by the discharge, disposal or effusion of any substance, object or waste or any other incidental percolation through the head of the bore-hole or the mouth of the well.

(2) The discharge or effusion onto or into the ground around the head of any bore-hole or the mouth of any well within the replenishment area of any substance, object or waste, including used engine oil originating from any pumping station serving such bore-hole or well is hereby prohibited.

(3) The effusion of acid waters or waters which contain increased salts or metals into streams or onto or into the ground within the replenishment area which may pollute the waters of the Dam is hereby prohibited.

6.- (1) Where it is proposed to construct any works for the abstraction of water for domestic or other purposes from wells or bore-holes within the replenishment area, the Chief Officer may require such measures to be taken as he deems necessary to prevent pollution of the waters of the Dam by the flow of surface water or the percolation of substances from the surface into the Dam.

(2) Water may only be abstracted within the replenishment area from such depth as the Chief Officer considers sufficient having regard to the prevailing conditions in that area and in any case not less than five metres from the surface of the ground. Where it is intended to abstract water from a borehole, that part of the borehole between the walls and the pipes in the section from the head of the bore-hole to the water abstraction point shall be cemented or packed with clay.

(3) The surface section of any bore-hole within the replenishment area shall be rendered impermeable either by replacing the soil at the head thereof by a cement or clay slab 0.5 to 1.0 metres thick with a radius of at least three times the diameter of the bore-hole and extending to meet that part of the bore-hole which has been cemented or packed with clay as provided in paragraph 2 or by any other means the Chief Officer may deem satisfactory.

(4) The Chief Officer may impose such other requirements as he deems necessary for the protection of any works for the abstraction of water within the replenishment area including disinfection of the works, the impermeability of the site of the pumping station and the prevention of percolation through the different lithological formations of the bore-hole.

7.-(1) The immediate surroundings of any waterworks within the replenishment area from which water is abstracted regularly or periodically for domestic, agricultural or any other use, shall be strictly protected from any activity likely to cause pollution. Such waterworks shall be properly fenced and, depending on the characteristics of the aquifer, no human activity whatsoever shall be permitted within a radius of between 10 and 50 metres from such waterworks except for activities which are directly related to water abstraction or farming and which may not cause any pollution to the underground water.

(2) The Chief Officer may impose such requirements as he deems necessary for the protection from flooding, erosion or other factors which may have an adverse effect on any works for the abstraction of water including the construction of dykes for this purpose.

8. This Order shall come into force on the date of its publication in the Gazette.

***Substances and Groups of Substances***

1. Organic salt compounds and substances from which such compounds may occur in the water environment;
2. Organophosphoric compounds;
3. Organic tin compounds;
4. Substances which in the water environment or through it, have established carcinogenic, teratogenic or transmutational qualities;
5. Mercury and its compounds;
6. Cadmium and its compounds;
7. Mineral oils and hydrocarbons;
8. Cyanogen and its compounds;
9. Resistant synthetic substances or materials which are either found floating, or in suspense, or subsided and which may prevent the use of the waters for any purpose.

2. Biocides and their bye-products which are not included in Table 1a;

4. Toxic or resistant organic compounds of pyritium and substances which may cause the formation of such compounds in the water, other than biologically harmless substances or substances which transform into harmless very quickly in the water;
5. Inorganic compounds of phosphorous and elemental phosphorous;
6. Non-resistant mineral oils and hydrocarbons of petrolic origin;
7. Cyanides, fluorides;
8. Substances which have an adverse effect on the oxygen balance, mainly ammonia and nitrites.

**THE GAME AND WILD BIRDS (PROTECTION  
AND DEVELOPMENT) ORDINANCE, 1974**

(Ordinances 11 of 1974, 1 of 1982, 3 of 1985, 9 of 1988,  
20 of 1989, 13 of 1991 and 15 of 1993).

**NOTICE UNDER SECTION 27 (1) (b).**

In exercise of the powers conferred upon him by paragraph (b) of subsection (1) of section 27 of the Game and Wild Birds (Protection and Development) Ordinance 1974, the Area Officer Akrotiri, with the approval of the Chief Officer, hereby authorises any holder of a valid game licence to shoot, take or pursue larks, quails, jackdaws, crows, turtle doves, wood-pigeons, rock-pigeons, magpies, sparrows and foxes, in the areas set out in the Schedule hereto, during the period commencing on Sunday 1<sup>st</sup> November 1998 and ending on Wednesday 31st March 1999 inclusive, subject to the following terms and conditions:-

- (a) shooting shall take place between sunrise and sunset only;
- (b) no dogs shall be allowed to accompany the hunters;
- (c) no fires shall be kindled;
- (d) hunters shall keep 200 metres away from main roads;
- (e) no farm or other cultivated land where there is a risk of damage being caused to fruit trees, vegetable gardens, citrus plantations, cereal crops or vineyards shall be entered;
- (f) shot-guns shall be carried to and from the areas specified in this notice, dismantled;
- (g) hunters shall carry with them their game licence, their gun possession licence and the certificate of registration of their gun;
- (h) the shooting of wild birds on Electricity or CYTA cables is prohibited.

2. This notice may be revoked at any time.

**S C H E D U L E**

Area 'A' will remain closed.

**AREA 'B'**

All that area which lies west of the Kouris river, bounded to the south by coast line, to the west by Curium Beach track and to the north by a line 200 metres south of M.1 and the main Limassol - Paphos road between the junction with the Curium Beach track and the junction with the M.1. This area extends to the east of Kouris river, again 200 metres south of M.1 and covers an area in the form of a triangle, bounded on one side by the river, on another by the coast line and on the third side by the track which demarcates the Game Reserve Area (Ayios Demetrianos locality). It further extends south of the track which leads to the fish farm to contain the locality

known as "Salipes". in as far as it lies between the track which demarcates the Upper Marsh game reserve and the coast as far as the "CYBARCO" premix plant, as signposted on the ground.

#### AREA 'C1'

All that area which lies south of the Limassol - Paphos road in the Ypsonas village area bounded to the north by the SBA boundary line commencing at boundary pillar 184 straight to west up to where such boundary line crosses Elefsinos Street, thence along Elefsinos Street to a southerly direction at a length of 600 metres up to its junction with the Ypsonas land consolidation road; thence southerly along the said land consolidation road at a length of 450 metres up to its junction with another land consolidation road; thence easterly, northerly and again easterly along this latter land consolidation road at a length of 350 metres up to its junction with a temporary track, thence easterly along this temporary track at a length of 250 metres up to its junction with another land consolidation road at the locality "Toumbi"; thence southerly along this land consolidation road up to its junction with Papanicolis Street; thence northeasterly along Papanicolis Street up to the point of commencement as signposted on the ground.

#### AREA 'C2'

All that area which lies south of the Limassol - Paphos road on the Ypsonas and Kolossi village areas bounded to the north by the SBA boundary line commencing at boundary pillar 170 straight to west and southwest along the boundary line up to a point near boundary pillar 155; thence southeasterly and southwesterly along the Kolossi - Ypsonas boundary line at a length of 1000 metres up to its intersection with the Kolossi - Trakhoni farm road; thence easterly along the said farm road which lies along the Kolossi - Ypsonas and Trakhoni - Ypsonas boundary line up to Pelentrides farm. Thence northerly along a land consolidation farm road at a length of 2200 metres and further along Smyrnis road in Ypsonas village up to the point of commencement as signposted on the ground.

AND DEVELOPMENT) ORDINANCE 1974

(Ordinances 11 of 1974, 1 of 1982, 3 of 1985, 9 of 1988,  
20 of 1989, 13 of 1991 and 15 of 1993).

NOTICE UNDER SECTION 27 (1) (b).

---

In exercise of the powers conferred upon him by paragraph (b) of subsection (1) of section 27 of the Game and Wild Birds (Protection and Development) Ordinance 1974, the Area Officer Akrotiri, with the approval of the Chief Officer, hereby authorises any holder of a valid game licence to shoot, take or pursue lap-wings, jackdaws, wood-pigeons, rock-pigeons, thrushes, starlings, woodcocks, ducks, snipes, sparrows, crows, magpies and foxes, in the areas set out in the Schedule hereto, during the period commencing on Sunday 3rd January 1999 and ending on Sunday 28th February 1999 inclusive, subject to the following terms and conditions:-

- (a) shooting shall take place on Sundays and Wednesdays only;
- (b) shooting shall take place between sunrise and sunset only;
- (c) no dogs shall be allowed to accompany the hunters;
- (d) no fires shall be kindled;
- (e) hunters shall keep 200 metres away from main roads;
- (f) no farm or other cultivated land where there is a risk of damage being caused to fruit trees, vegetable gardens, citrus plantations, cereal crops or vineyards shall be entered;
- (g) shot-guns shall be carried to and from the areas specified in this notice, dismantled;
- (h) hunters shall carry with them their game licence, their gun possession licence and the certificate of registration of their gun;
- (i) the shooting of wild birds on Electricity or CYTA cables is prohibited.

2. This notice may be revoked at any time.

**SCHEDULE**

All those areas of Episkopi, Sotira and Paramali villages in so far as they lie within the Akrotiri Sovereign Base Area, excluding any Game Reserves published in the Gazette and marked on the ground by appropriate sign-posts.
