(CYPRUS) ORDER 1946.

---

**ORDER MADE BY THE ADMINISTRATOR  
UNDER DEFENCE REGULATION 63.**

---

In exercise of the powers vested in him by Defence Regulation 63, as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order 1946, [as applied to and adapted in the Sovereign Base Areas of Akrotiri and Dhekelia Order in Council 1960 and the Laws (Adaptation and Interpretation) (Consolidation and Extension) Ordinance 1968] which Order continues in force by virtue of the provisions of the Supplies and Services (Transitional Powers) (Continuation) Ordinance, the Competent Authority for the purpose of the said Regulation hereby makes the following Order:-

1. Subject to the restrictions and conditions contained in the First Schedule to this Order, the use for the purpose of constructing a temporary diversion for the Dhekelia-Protaras Highway, Xylotymbou-Ormidhia Section, through the Dhekelia Sovereign Base Area, of the land and property specified in the Second Schedule hereto (hereinafter referred to as "the land") during a period of 6 months as from 15 May 1999 is hereby authorised.
2. The persons using the land in pursuance of this Order are entitled to do thereon or in relation thereto such acts as may be necessary for the purpose referred to in paragraph 1.
3. The exercise of any right of way over the land and of any other right relating thereto which is enjoyed by any person whether by virtue of any interest in the land or otherwise, is hereby prohibited during the period this Order shall remain in force.

**FIRST SCHEDULE**

1. The land shall be occupied and used for the purpose of constructing a temporary diversion for the Dhekelia-Protaras Highway, Xylymbou Ormidhia Section, through the Dhekelia Sovereign Base Area.

2. At the expiration of this Order, that part of the land which shall not have been compulsorily acquired by an Order made under Section 6 of the Land Acquisition Ordinance (Cap.226 – Laws of Cyprus, as amended from time to time), shall be returned to the persons entitled thereto, free of any erection, structure or construction erected or constructed thereon after the making of this Order.

3. Compensation shall be paid to the persons having an interest in the land for its use and occupation under this Order.

**SECOND SCHEDULE**

The private immovable property within the Sovereign Base Area of Dhekelia, in the village of Ormidhia of Larnaca District, under and in connection with plot No. 395 (part) of the Government Survey Plan XLI.22.W2 of Ormidhia village.

The land area of the above immovable property comprises 45 square metres or therabouts and is shown coloured red on the relative set of plans kept at the Headquarters of the Sovereign Base Areas Administration.

THE EMPLOYERS LIABILITY (COMPULSORY  
INSURANCE) ORDINANCE 1999

(Ordinance 1 of 1999)

**REGULATIONS MADE BY THE ADMINISTRATOR  
UNDER SECTIONS 3, 5, 15 AND 21.**

In exercise of the powers vested in him by sections 3, 5, 15 and 21 of the Employers Liability (Compulsory Insurance) Ordinance 1999, the Administrator hereby makes the following Regulations:-

Short title.

1. These Regulations may be cited as the Employers Liability (Compulsory Insurance) Regulations 1999.

Interpretation.

2. Unless the context otherwise requires, the words and terms in these Regulations and in the forms prescribed therein shall have the meanings assigned to them by the Employers Liability (Compulsory Insurance) Ordinance 1999 (hereinafter referred to as "the Ordinance").

Certificate of  
Insurance.

3. - (1) The certificate of insurance for the purposes of section 5(2) of the Ordinance, shall be in the form, and contain the matters, as set out in Form EE1 in the Schedule to these Regulations.

Form EE1.

(2) Where a certificate of insurance is issued by an insurer in the form of a temporary cover note, pending the issue of a policy of insurance, it shall be in the form and contain the matters as set out in Form EE2 in the Schedule hereto.

Form EE2.

(3) The certificate of insurance shall be printed on white paper in black letters and shall not contain any advertisement or other matter that is not specified in the said Forms EE1 and EE2.

4. Any employer who employs from time to time a person or persons for occasional services for short periods of time not exceeding in total eight hours per week in respect of each such person so employed, shall fall within an exempted category for the purposes of section 3(c) of the Ordinance.

5. The affidavit concerning the loss or destruction of a certificate of insurance for the purposes of section 8 of the Ordinance shall be in the form as set out in Form EE3 in the Schedule hereto.

6. - (1) For the purposes of section 15(1)(b) of the Ordinance the persons to whom an employer is required to produce or send a certificate of insurance or a copy thereof, are the following:-

- (a) the Superintendent of Insurance or his representative;
- (b) an authorised representative of the Insurers Labour Indemnity Fund;
- (c) the Chief Constable or his representative;

Inspection of

(2) For the purposes of paragraph (c) of subsection (1) of section 15 of the Ordinance, the persons authorised to inspect a policy or a copy thereof, shall be those persons referred to in sub-paragraph (1) above and in paragraphs (a) and (b) of subsection (1) of the said section 15.

7. The instrument of appointment of an inspector, issued for the purposes of section 16 of the Ordinance, shall be in the form as set out in Form EE4 in the Schedule hereto.

8. - (1) The minimum sums for which an employer is required to insure, and to maintain insurance of his insurable liabilities under and in accordance with the Ordinance shall be:-

Minimum sums of insurance against liability.

- (a) for every insurable liability, fifty thousand pounds for each of his employees;
- (b) for every event or series of events which arise from the same cause, two million pounds;
- (c) for any period of insurance a maximum cover of three million pounds.

(2) Where more than one claim arising from the same event or series of events, as aforesaid, is made, which exceed the sum of two million pounds in total, the minimum sum of fifty thousand pounds for every employee shall be reduced in proportion to the sum which corresponds to the sum of two million pounds as against the total sums awarded.

9. Any person who contravenes any provision of these Regulations shall be guilty of an offence and shall be liable on conviction to imprisonment not exceeding six months or to a fine not exceeding four hundred and fifty pounds or to both such penalties.
