**THE POWERS AND DUTIES (OFFICERS OF THE REPUBLIC
OF CYPRUS) (CONSOLIDATION) ORDINANCE 1976
(Ordinance 4 of 1976).**

ORDER MADE BY THE ADMINISTRATOR UNDER SECTION 3.

In exercise of the powers conferred upon him by section 3 of the Powers and Duties (Officers of the Republic of Cyprus) (Consolidation) Ordinance 1976 and all other powers enabling him in that behalf, the Administrator hereby makes the following Order:-

1. This Order may be cited as the Powers and Duties (Officers of the Republic of Cyprus) (Special Provisions) (Consolidation) (Amendment) Order 2000 and shall be read as one with the Powers and Duties (Officers of the Republic of Cyprus) (Special Provisions) (Consolidation) Order 1982 as amended from time to time (hereinafter referred to as "the principal Order").

2. Part I of the Schedule to the principal Order is hereby amended by adding at the end thereof the following new items:-

THE FOOD HYGIENE (GENERAL) REGULATIONS, 1989

**APPOINTMENT OF FOOD HYGIENE CONTROLLER
UNDER REGULATION 3(1).**

In exercise of the powers conferred upon him by paragraph 1 of regulation 3 of the Food Hygiene (General) Regulations 1989, the Administrator hereby appoints A Charnick Esquire, to be the Food Hygiene Controller and to exercise the powers and perform the duties conferred or imposed by the said Regulations with effect from 1st August 2000.

2. Public Instrument No. 23 of 1999 is hereby revoked.
