**THE PUBLIC ROADS (PROTECTION) ORDINANCE**  
 (Cap. 83 – Laws of Cyprus – and Ordinance 27 of 1961)

**AUTHORISATION UNDER SECTION 9**

In exercise of the powers conferred upon me by section 9 of the Public Roads (Protection) Ordinance and of all other powers enabling me in that behalf, I, the Chief Officer Sovereign Base Areas, hereby amend the Schedule to Public Instrument No. 20 of 1986 as follows:-

In Part I AKROTIRI AREA by adding the following particulars in Columns 1, 2 and 3 at the end thereof:-

A point on the M1 road near electricity pole No. 19	East to West	A point on the M1 road near electricity pole No. 24
