## No. 79

THE POWERS AND DUTIES (OFFICERS OF THE  
REPUBLIC OF CYPRUS) ORDINANCE 2002

(Ordinance 12 of 2002)

**ORDER MADE UNDER SECTION 3**

In exercise of the powers conferred upon him by section 3 of the Powers and Duties (Officers of the Republic of Cyprus) Ordinance 2002, and of all other powers enabling him in that behalf, the Administrator hereby makes the following Order:-

1. This Order may be cited as the Powers and Duties (Officers of the Republic of Cyprus) (Amendment) (No. 3) Order 2002.

2. – (1) In this Order –

“the Schedule” means the Schedule to the Powers and Duties (Officers of the Republic of Cyprus) Order 2002.

(2) Any reference in this Order to a numbered column is to be construed as a reference to the correspondingly numbered column in the Schedule.

3. Part I of the Schedule (which relates to Ordinances) shall be amended in accordance with paragraphs 4 to 6 of this Order.

4. There shall be inserted in columns 1 to 5 respectively immediately below the entries relating to the Debtors Relief (Temporary Provisions) Ordinance (which is mentioned in column 2) the following –

- (a) “Ordinance 18/2002” (to be inserted in column 1);
- (b) “Disabled Persons Ordinance.” (to be inserted in column 2);
- (c) “10 and 11.” (to be inserted in column 3);
- (d) “Chief Officer.” (to be inserted in column 4);
- (e) “Minister of Labour and Social Insurance.” (to be inserted in column 5).

5. In column 3 of the entries relating to the Health and Safety at Work Ordinance (which is mentioned in column 2) for the figures “40,42,49,50,52,53 and 54” there shall be substituted the figures “42(2) and 49”.

6. There shall be inserted in columns 1 to 5 respectively immediately below the entries relating to the Propagating Material Ordinance (which is mentioned in column 2) the following –

- (a) “Ordinance 17/2002” (to be inserted in column 1);
- (b) “Protection of Animals used for Experimental Purposes.” (to be inserted in column 2);
- (c) “6 to 15 inclusive and 19.” (to be inserted in column 3);
- (d) “Chief Officer.” (to be inserted in column 4);

(e) "Director, Department of Veterinary Services." (to be inserted in column 5).

THE POWERS AND DUTIES (OFFICERS OF THE

(Ordinance 12 of 2002)

ORDER MADE UNDER SECTION 12

---

In exercise of the powers conferred upon him by section 12 of the Powers and Duties (Officers of the Republic of Cyprus) Ordinance 2002, and of all other powers enabling him in that behalf, the Administrator hereby makes the following Order:-

1. This Order may be cited as the Powers and Duties (Officers of the Republic of Cyprus) Ordinance (Variation of Schedule) (No.2) Order 2002.

2. – (1) The Schedule to the Powers and Duties (Officers of the Republic of Cyprus) Ordinance 2002<sup>(a)</sup> shall be varied in accordance with paragraphs 3 and 4 of this Order.

(2) References in paragraphs 3 and 4 of this Order to column 1 shall be construed as references to the columns headed “Short Title of Ordinance” in the Schedule referred to in sub-paragraph (1) above and references to column 2 shall be construed as references to the columns headed “Reference” in that Schedule.

3. Immediately below the entry relating to the Debtors Relief (Temporary Provisions) Ordinance (which is mentioned in column 1) there shall be inserted –

- (a) in column 1, the words “Disabled Persons Ordinance.”; and
- (b) in column 2, the words and figures “Ordinance 18/2002.”.

4. Immediately below the entries relating to the Protection and Welfare of Animals Ordinance (which is mentioned in column 1) there shall be inserted –

- (a) in column 1, the words “Protection of Animals Used for Experimental Purposes Ordinance.”; and
- (b) in column 2, the words and figures “Ordinance 17/2002”.
