

No.19**THE POWERS AND DUTIES (OFFICERS OF THE REPUBLIC OF CYPRUS) ORDINANCE 2002**

(Ordinance 12 of 2002 as amended by Public Instrument 94 of 2002)

ORDER MADE UNDER SECTION 3

In exercise of the powers conferred upon him by section 3 of the Powers and Duties (Officers of the Republic of Cyprus) Ordinance 2002, and of all other powers enabling in that behalf, the Administrator hereby makes the following Order:-

1. This Order may be cited as the Powers and Duties (Officers of the Republic of Cyprus) (Amendment) Order 2003.

2. - (1) In this Order-

“the Schedule” means the Schedule to the Powers and Duties (Officers of the Republic of Cyprus) Order 2002.

(2) Any reference in this Order to a numbered column is to be construed as a reference to the correspondingly numbered column in the Schedule.

3. - (1) Part I of the Schedule (which relates to Ordinances) shall be amended in accordance with paragraphs 4 to 7 of this Order.

(2) Part II of the Schedule (which relates to public instruments) shall be amended in accordance with paragraphs 8 and 9 of this Order.

4. There shall be inserted in columns 1 to 5 respectively immediately below the entries relating to the Control of Atmospheric Pollution Ordinance (which is mentioned in column 2) the following-

- (a) “Ordinance 30/2002.” (to be inserted in column 1);
- (b) “Control of Misleading and Comparative Advertisements Ordinance.” (to be inserted in column 2);
- (c) “6(1), (2) and (3), 7(1) and (2) and 10(1), (2), (4), (5), (6) and (8).” (to be inserted in column 3);
- (d) “Chief Officer.” (to be inserted in column 4);
- (e) “Director, Competition and Consumer Protection Service.” (to be inserted in column 5).

5. There shall be inserted in columns 1 to 5 respectively immediately below the entries relating to the Elementary Education Ordinance (which is mentioned in column 2) the following:-

- (a) “Ordinance 25/2002.” (to be inserted in column 1);
- (b) “Employment Rights (Part-time Employees) Ordinance.” (to be inserted in column 2);
- (c) “6(3) and (4), 10(1) and (3) and 13.” (to be inserted in column 3);
- (d) “Chief Officer.” (to be inserted in column 4);

(e) “Minister of Labour and Social Insurance.” (to be inserted in column 5).

6. There shall be inserted in columns 1 to 5 respectively immediately below the entries relating to the Paramali (Village Commission) (Election, Constitution and Powers) Ordinance (which is mentioned in column 2) the following:-

- (a) “Ordinance 39/2002.” (to be inserted in column 1);
- (b) “Parental Leave and Leave on Grounds of Force Majeure.” (to be inserted in column 2);
- (c) “11(1) and (2).

- (d) “Chief Officer. Chief Officer.” (to be inserted in column 4);
- (e) “Director, Department of Social Insurance Services. Minister of Labour and Social Insurance.” (to be inserted in column 5).

7. There shall be inserted in columns 1 to 5 respectively immediately below the entries relating to the Petroleum Ordinance (which is mentioned in column 1) the following:-

- (a) “Ordinances 23/1964, 10/1970, 4/1971, 17/1989 and 31/2002.” (to be inserted in column 1);
- (b) “Pharmacy and Poisons Ordinance.” (to be inserted in column 2);
- (c) “5(1) and (2), proviso to 6(1), 9(2), (4) and (5), 10(1), 11(2), 12, 16(2) and (3), 20(2), (3), (4), (5), (6) and (7), 22, 23(1) and (2), 24, 25, 26(1) and 36(1).” (to be inserted in column 3);
- (d) “Chief Officer.” (to be inserted in column 4);
- (e) “Chairman, Pharmacy Council.” (to be inserted in column 5).

8. There shall be inserted in columns 1 to 5 respectively immediately below the entries relating to the Animals, Carcasses and Animal Products (Prohibition of Removal and Transportation) Order (which is mentioned in column 1) the following:-

- (a) “Animal (Scientific Experiments) Regulations.” (to be inserted in column);
- (b) “P.I. 88/2002.” (to be inserted in column 2);
- (c) “3(1) and (2), 4(1), (2) and (3), 5(1), (2) and (3) and 8.” (to be inserted in column 3);
- (d) “Chief Officer.” (to be inserted in column 4);
- (e) “Director, Department of Veterinary Services.” (to be inserted in column 5).

9. There shall be inserted in columns 1 to 5 respectively immediately below the entries relating to the Public Health (Anti-Malaria) (Spraying of Vehicles, etc) Regulations (which are mentioned in column 1) the following:-

- (a) "Quick-frozen Food Regulations." (to be inserted in column 1);
- (b) "P.I. 86/2002." (to be inserted in column 2);
- (c) "7(1)." (to be inserted in column 3);
- (d) "Chief Officer." (to be inserted in column 4);
- (e) "Minister of Health." (to be inserted in column 5).
