**THE POWERS AND DUTIES (OFFICERS OF THE REPUBLIC
OF CYPRUS) ORDINANCE 2002**
(Ordinance 12 of 2002)

ORDER MADE UNDER SECTION 12

In exercise of the powers conferred upon him by section 12 of the Powers and Duties (Officers of the Republic of Cyprus) Ordinance 2002, and of all other powers enabling him in that behalf, the Administrator hereby makes the following Order:-

Citation

1. This Order may be cited as the Powers and Duties (Officers of the Republic of Cyprus) Ordinance (Variations to Schedule) Order 2003.

Variations to Schedule

2. – (1) The Schedule to the Powers and Duties (Officers of the Republic of Cyprus) Ordinance 2002 shall be varied in accordance with paragraphs 3 to 7 of this Order.

(2) References in paragraphs 3 to 7 of this Order to column 1 shall be construed as references to the columns headed “Short Title of Ordinance” in the Schedule referred to in sub-paragraph (1) above, and references to column 2 shall be construed as references to the columns headed “Reference” in that Schedule.

3. Immediately below the entry relating to the Control of Atmospheric Pollution Ordinance (which is mentioned in column 1) there shall be inserted the following-

- (a) in column 1, the words “Control of Misleading and Comparative Advertisements Ordinance”; and
- (b) in column 2, the words and figures “Ordinance 30/2002”.

4. Immediately below the entry relating to the Elementary Education Ordinance (which is mentioned in column 1) there shall be inserted the following-

- (a) in column 1, the words “Employees at Places of Entertainment (Terms of Employment) Ordinance”; and
- (b) in column 2, the words and figures “Ordinance 29/2002”.

5. Immediately below the entry relating to the Employment Rights (Particulars of Employment) Ordinance (which is mentioned in column 1) there shall be inserted the following-

- (a) in column 1, the words “Employment Rights (Part-time Employees) Ordinance”; and
- (b) in column 2, the words and figures “Ordinance 25/2002”.

6. Immediately below the entry relating to the Paramali (Village Commission) (Election, Constitution and Powers) Ordinance (which is mentioned in column 1) there shall be inserted the following-

(a) in column 1, the words “Parental Leave and Leave on Grounds of Force Majeure Ordinance”; and

(b) in column 2, the words and figures “Ordinance 39/2002”.

7. Immediately below the entry relating to the Petroleum Ordinance (which is mentioned in column 1) there shall be inserted the following-

(a) in column 1, the words “Pharmacy and Poisons Ordinance”; and

(b) in column 2, the words and figures “Ordinances 23/1964, 10/1970, 4/1971, 17/1989 and 31/2002”.
