

No. 74**THE POWERS AND DUTIES (OFFICERS OF THE REPUBLIC OF CYPRUS) ORDINANCE 2002**

(Ordinance 12 of 2002 as amended by Public Instruments 94 of 2002 and 20 of 2003)

ORDER MADE UNDER SECTION 3

In exercise of the powers conferred upon him by section 3 of the Powers and Duties (Officers of the Republic of Cyprus) Ordinance 2002, the Administrator hereby makes the following Order:-

1. This Order may be cited as the Powers and Duties (Officers of the Republic of Cyprus) (Amendment) (No. 3) Order 2003.

2. – (1) In this Order –

“the Schedule” means the Schedule to the Powers and Duties (Officers of the Republic of Cyprus) Order 2002.

P.I.40/2002 as amended by P.I. 48/02, 72/02, 79/02, 93/02, 19/03 and 45/03.

(2) Any reference in this Order to a numbered column is to be construed as a reference to the correspondingly numbered column in the Schedule.

3. - (1) Part I of the Schedule (which relates to Ordinances) shall be amended in accordance with paragraphs 4, 5, 6 and 7 of this Order.

(2) Part II of the Schedule (which relates to public instruments) shall be amended in accordance with paragraphs 8 and 9 of this Order.

4. There shall be inserted in columns 1 to 5 respectively immediately above the entries relating to the Employment Rights (Part-time Employees) Ordinance (which is mentioned in column 2) the following –

- (a) “Ordinance 1/2003.” (to be inserted in column 1);
- (b) “Employment Rights (Insolvency of Employer) Ordinance.” (to be inserted in column 2);
- (c) “Proviso to section 3(1).” (to be inserted in column 3);
- (d) “Chief Officer.” (to be inserted in column 4);
- (e) “Director, Department of Social Insurance Services.” (to be inserted in column 5).

5. There shall be inserted in columns 1 to 5 respectively immediately below the entries relating to the Immovable Property (Transfer and Mortgage) Ordinance (which is mentioned in column 2) the following –

- (a) “Ordinance 2/2003.” (to be inserted in column 1);
- (b) “Improvement of Animal Breeds Ordinance.” (to be inserted in column 2);

- (c) “4(5) and 8(1).” (to be inserted in column 3);
- (d) “Chief Officer.” (to be inserted in column 4);
- (e) “Minister of Agriculture, Natural Resources and Environment.” (to be inserted in column 5).

6. There shall be inserted in columns 1 to 5 respectively immediately below the entries relating to the Livestock Enumeration Ordinance (which is mentioned in column 2) the following –

- (a) “Ordinance 3/2003.” (to be inserted in column 1);
- (b) “Mass Dismissals Ordinance.” (to be inserted in column 2);
- (c) “5(2), 6, 7, 8 and 9.” (to be inserted in column 3);
- (d) “Chief Officer.” (to be inserted in column 4);
- (e) “Minister of Labour and Social Insurance.” (to be inserted in column 5).

7. There shall be inserted in columns 1 to 5 respectively immediately below the entries relating to the Old Peoples and Incapacitated Persons Homes Ordinance (which is mentioned in column 2) the following –

- (a) “Ordinance 5/2003.” (to be inserted in column 1);
- (b) “Organisation of Working Time Ordinance.” (to be inserted in column 2);
- (c) “7(4)(d) and (e), 12 and 20.” (to be inserted in column 3);
- (d) “Chief Officer.” (to be inserted in column 4);
- (e) “Minister of Labour and Social Insurance.” (to be inserted in column 5).

8. There shall be inserted in columns 1 to 5 respectively immediately below the entries relating to the Grain Control (Milling and Bakeries) Regulations (which are mentioned in column 1) the following –

- (a) “Health and Safety at Work (Protection of Employees from Noise) Regulations.” (to be inserted in column 1);
- (b) “P.I. 24/2003.” (to be inserted in column 2);
- (c) “10” (to be inserted in column 3);
- (d) “Chief Officer.” (to be inserted in column 4);
- (e) “Minister of Labour and Social Insurance.” (to be inserted in column 5).

9. There shall be inserted in columns 1 to 5 respectively immediately below the entries relating to the Locust Regulations (which are mentioned in column 1) the following –

- (a) “Management of Health and Safety at Work Regulations.” (to be inserted in column 1);
- (b) “P.I. 22/2003.” (to be inserted in column 2);
- (c) “6(13).” (to be inserted in column 3);

- (d) "Chief Officer." (to be inserted in column 4);
- (e) "Minister of Labour and Social Insurance." (to be inserted in column 5).
