**THE POWERS AND DUTIES (OFFICERS OF THE  
REPUBLIC OF CYPRUS) ORDINANCE 2002**

(Ordinance 12 of 2002 as amended by Public Instruments 98 of  
2003 and 24 of 2004)

**ORDER MADE UNDER SECTION 3**

In exercise of the powers conferred upon him by section 3 of the Powers and Duties (Officers of the Republic of Cyprus) Ordinance 2002, and of all other powers enabling him in that behalf, the Administrator hereby makes the following Order:—

**1.** This Order may be cited as the Powers and Duties (Officers of the Republic of Cyprus) (Amendment) (No. 2) Order 2004.

**2.**—(1) In this Order—

“the Schedule” means the Schedule to the Powers and Duties (Officers of the Republic of Cyprus) Order 2002<sup>(a)</sup>.

(2) Any reference in this Order to a numbered column is to be construed as a reference to the correspondingly numbered column in the Schedule.

**3.** Part I of the Schedule (which relates to Ordinances) is amended in accordance with paragraphs 4 to 11 below.

**4.** There are inserted in columns 1 to 5 respectively immediately below the entries relating to the Animal Feeding Stuffs and Animal Feeding Stuff Additives (Control of Quality, Supply and Use) Ordinance 2003 (which is mentioned in column 1) the following—

- (a) “Animal Foodstuffs Hygiene Ordinance 2004” (to be inserted in column 1);
- (b) “Ordinance 2/2004” (to be inserted in column 2);
- (c) “5(3), 2 (insofar as it concerns the appointment of official veterinarians and the authorisation of veterinary inspectors), 5(1), 5(2), 5(4) and 5(5), 6, 7, 8, 9, 10(1), 10(2) and 10(5), 11(1) and 13(1) and 13(2)” (to be inserted in column 3);
- (d) “Administrator Chief Officer” (to be inserted in column 4);
- (e) “Minister of Agriculture, Natural Resources and Environment Director, Department of Veterinary Services” (to be inserted in column 5).

**5.** There are inserted in columns 1 to 5 respectively immediately below the entries relating to the Animal Foodstuffs Hygiene Ordinance 2004 (which are inserted by paragraph 4 above) the following—

- (a) “Animal Health Ordinance 2002” (to be inserted in column 1);
- (b) “Ordinance 5/2002” (to be inserted in column 2);
- (c) “4, 5(1), 8(except for paragraphs (c) and (i)), 11(3) and 12” (to be inserted in column 3);

---

(a) The Schedule was substituted by P.I. 99/2003 and further amended by P.I. 24/2004.

- (d) “Chief Officer” (to be inserted in column 4);
- (e) “Director, Department of Veterinary Services” (to be inserted in column 5).

**6.** In column 1 of the entries immediately below the entries relating to the Antiquities Ordinance 1975 (which is mentioned in that column) for “piculture” there is substituted “Apiculture”.

**7.** There are inserted in columns 1 to 5 respectively immediately below the entries relating to the Civil Procedure Ordinance (which is mentioned in column 1) the following—

- (a) “Classification of Wood in the Rough Ordinance 2004” (to be inserted in column 1);
- (b) “Ordinance 5/2004” (to be inserted in column 2);
- (c) “6 ” (to be inserted in column 3);
- (d) “Chief Officer” (to be inserted in column 4);
- (e) “Director, Department of Forests” (to be inserted in column 5).

**8.** The entries relating to the Fish Farming Ordinance 2001 (which is mentioned in column 1) are omitted.

**9.** There are inserted in columns 1 to 5 respectively immediately below the entries relating to the Mass Dismissals Ordinance 2003 (which is mentioned in column 1) the following—

- (a) “Meat Hygiene Ordinance 2004” (to be inserted in column 1);
- (b) “Ordinance 3/2004” (to be inserted in column 2);
- (c) “5(1)(a), 7 and 8(1) ” (to be inserted in column 3);
- (d) “Chief Officer” (to be inserted in column 4);
- (e) “Director, Department of Veterinary Services” (to be inserted in column 5).

**10.** There are inserted in columns 1 to 5 respectively immediately below the entries relating to the Places of Entertainment Ordinance 1999 (which is mentioned in column 1) the following—

- (a) “Plant (Phytosanitary Measures) Ordinance 2004” (to be inserted in column 1);
- (b) “Ordinance 8/2004” (to be inserted in column 2);
- (c) “5(1), 6, 7, 8(2) and (3), 10(1) and (5), 11(1), (2) and (5), 12(2) and (3), 13(4), (10) and (11), 14, 14A, 15, 19(2) and (4) ” (to be inserted in column 3);
- (d) “Chief Officer” (to be inserted in column 4);
- (e) “Director, Department of Agriculture” (to be inserted in column 5).

**11.** There are inserted in columns 1 to 5 respectively immediately below the entries relating to the Poultrymeat (Specifications for the Production, Grading, Marking and Trading of Poultrymeat) Ordinance 2002 (which is mentioned in column 1) the following—

- (a) “Promotion of Renewable Sources of Energy and Conservation of Energy Ordinance 2004” (to be inserted in column 1);
- (b) “Ordinance 6/2004” (to be inserted in column 2);

- (c) “3(2) and 5(6) ” (to be inserted in column 3);
- (d) “Chief Officer” (to be inserted in column 4);
- (e) “Minister of Commerce, Industry and Tourism” (to be inserted in column 5).
