**THE PROTECTION AND MANAGEMENT OF GAME AND  
WILD BIRDS ORDINANCE 2004.**

(Ordinance 15 of 2004)

**ORDER UNDER SECTION 43**

In exercise of the powers vested in me under section 43 of The Protection and Management of Game and Wild Birds Ordinance 2004, I hereby prescribe the areas defined in the Schedule herebelow to be temporary Game Reserves, for the corresponding periods specified therein.

SBA/AO(A)/TGR(04-05)/A, signed and sealed by me and deposited at the Area Office Akrotiri.</p>	<p>From the date of publication of this Order to the 28<sup>th</sup> August 2004 (both dates included); from 18<sup>th</sup> October 2004 to 30<sup>th</sup> October 2004 (both dates included); and from 1<sup>st</sup> March 2005 to 15<sup>th</sup> August 2005 (both dates included).</p>
2.	<p>The whole of the Sovereign Base Area of Akrotiri excluding:-</p> <p>(a) Any permanent Game Reserve areas which have been prescribed under various Public Instruments published in the Gazette, from time to time, and marked on the ground by appropriate sign-posts;</p> <p>(b) The area which commences at a point on the western coast of Episkopi bay with approximate Grid Reference 91903260, and extends to the east as far as the western boundary of the Phassouri Farm Game Reserve area, declared as such under Public Instrument No. 61 of 1985 and extended under Public Instrument No. 44 of 2000; thence in a northerly direction along the said boundary up to the southern side of the Queen's Bridge on the M.1 road; thence easterly along southern side of the M.1 road for a distance of about 200 meters and then across, up to the western boundary of the Kolossi Game Reserve area, declared as such under Public Instrument No. 61</p>	<p>From 29<sup>th</sup> August 2004 to 17<sup>th</sup> October 2004 (both dates included).</p>

of 1985; thence in a northerly direction along the said boundary up to the boundary of the Akrotiri Sovereign Base Area; thence along the boundary of the Akrotiri Sovereign Base Area, in consecutive westerly and southerly directions, up to the eastern boundary of the Episkopi Village Game Reserve area, declared as such under Public Instrument No. 61 of 1985; thence in a southerly direction along the said boundary, up to the M.1 road; thence in a westerly direction along the M.1 road, up to its junction with the old Limassol-Paphos road; thence in a westerly direction along the said road, up to its junction with the Agios Ermoyenis road; thence in a south-westerly direction along the said road, up to the coast line; thence in a south-easterly direction along the coast line and up to the point of commencement; all of which area is sign- posted on the ground.

The prescribed area is shown coloured red on a map, under identification no. SBA/AO(A)/TGR(04-05)/B, signed and sealed by me and deposited at the Area Office Akrotiri.

3. The whole of the Sovereign Base Area of Akrotiri excluding:-
- From 31<sup>st</sup> October 2004 to 28<sup>th</sup> February 2005 (both dates included), except on Wednesdays and Sundays.
- (a) Any permanent Game Reserve areas which have been prescribed under various Public Instruments published in the Gazette, from time to time, and marked on the ground by appropriate sign-posts;
- (b) The area which commences at a point on the coast of Episkopi bay with approximate Grid Reference 92953090, and extends to the east as far as the western boundary of the Akrotiri Forest Game Reserve area, declared as such under Public Instrument No. 41 of 1988; thence in a northerly direction, along the said boundary and the boundary of the Phassouri Farm Game Reserve area, declared as such under Public Instrument No. 61 of 1985 and extended under Public Instrument No. 44 of 2000, up to the southern side of Queen's Bridge on the M.1 road; thence in an easterly direction, along the southern side of the M.1 road, for a distance of about 200 metres and then across, up to the western boundary of the Kolossi Game Reserve area, declared as such under Public Instrument No. 61 of 1985; thence in a northerly direction along the said boundary, up to the boundary of the Akrotiri Sovereign Base Area in the vicinity of Erimi village; thence along the SBA boundary, consecutively in a westerly and southerly direction up to the eastern boundary of the Episkopi Village Game Reserve area, declared as such under Public Instrument No. 61 of 1985; thence in a southerly direction along the said boundary up to the M.1 road; thence across and in a westerly direction along the M.1 road up to its junction with the old Limassol-Paphos road; thence in a westerly direction along the said road up to its junction with the Agios

Ermoyenis road; thence in a south-westerly direction along the said road, up to the coast line; thence in a south-easterly direction along the coast line up to the point of commencement; all of which area is sign-posted on the ground.

- (c) Any parts of the Akrotiri Sovereign Base Area, within the administrative boundaries of the villages of Episkopi, Sotira, Paramali and Evdhimou, other than the area described in (b) above, which have not been declared as Game Reserve areas under the provisions of a relevant Ordinance.

The prescribed area is shown coloured red on a map, under identification no. SBA/AO(A)/TGR(04-05)/C, signed and sealed by me and deposited at the Area Office Akrotiri.
