

**No. 131****THE FISH FARMING ORDINANCE 2001**

(Ordinance 18/2001 as amended by 12/2003)

**REGULATIONS UNDER SECTION 23.**

In exercise of his powers under section 23 of the Fish Farming Ordinance 2001<sup>(a)</sup>, and under section 28A of the Interpretation Ordinance<sup>(b)</sup>, the Administrator hereby makes the following Regulations:—

**Citation and commencement**

1. These Regulations may be cited as the Fish Farming (General) Regulations 2004 and shall come into force on the day that they are published in the Gazette.

**Adoption of Republican public instrument No. 553/2002**

2. (1)—The Fish Farming (General) Regulations 2002 of the Republic (“the Republican Regulations”)<sup>(c)</sup>, which came into force in the Republic on 1<sup>st</sup> November 2002 are, subject to the modification in subsection (2), adopted under the Fish Farming Ordinance 2001 and accordingly, as from the date that these Regulations come into force, the Republican Regulations shall have effect in the Areas, so far as relevant and subject to any necessary modifications, as if they had been made under section 23 of the Fish Farming Ordinance 2001.

(2) A bid for permission to use a sea site for the purpose of fish farming shall be made and considered in accordance with the Republican Public Invitation to Bid Law<sup>(d)</sup>, and any regulations made under that Law, as if such Law and regulations had been enacted in the Areas.

**Adoption of Republican public instrument No. 911/2003**

3. The Fish Farming (General)(Amendment) Regulations 2003 of the Republic (“the Republican Amendment Regulations”)<sup>(e)</sup>, which came into force in the Republic on 19<sup>th</sup> December 2003 are adopted under the Fish Farming Ordinance 2001 and accordingly, as from the date that these Regulations come into force, the Republican Amendment Regulations shall have effect in the Areas, so far as relevant and subject to any necessary modifications, as if they had been made under section 23 of the Fish Farming Ordinance 2001.
