THE POWERS AND DUTIES (OFFICERS OF THE REPUBLIC
OF CYPRUS) ORDINANCE 2002
(Ordinance 12 of 2002 as amended by Public Instrument 98 of 2003)

ORDER MADE UNDER SECTION 3

In exercise of the powers conferred upon him by section 3 of the Powers and Duties (Officers of the Republic of Cyprus) Ordinance 2002, and of all other powers enabling him in that behalf, the Administrator hereby makes the following Order:-

1. This Order may be cited as the Powers and Duties (Officers of the Republic of Cyprus) (Amendment) Order 2004.

2. – (1) In this Order-
“the Schedule” means the Schedule to the Powers and Duties (Officers of the Republic of Cyprus) Order 2002^(a).

(2) Any reference in this Order to a numbered column is to be construed as a reference to the correspondingly numbered column in the Schedule.

3. – (1) Part I of the Schedule (which relates to Ordinances) is amended in accordance with paragraphs 4 to 8 below.

(2) Part II of the Schedule (which relates to public instruments) is amended in accordance with paragraph 9 below.

4. There are inserted in columns 1 to 5 respectively immediately below the entries relating to the Agricultural Produce (Export) Ordinance (which is mentioned in column 1) the following-

- (a) “ Agricultural Produce (Quality Control) Ordinance 2003” (to be inserted in column 1);
- (b) “ Ordinance 34/2003” (to be inserted in column 2);
- (c) “ 4(1)
12(1) and (4)” (to be inserted in column 3);
- (d) “ Chief Officer
Chief Officer” (to be inserted in column 4);
- (e) “ Agricultural Produce Inspection Service
Minister of Commerce, Industry and Tourism” (to be inserted in column 5).

5. There are inserted in columns 1 to 5 respectively immediately below the entries relating to the Akrotiri Community Ordinance 2001 (which is mentioned in column 1) the following-

- (a) “Animal Feeding Stuffs and Animal Feeding Stuff Additives (Control of Quality, Supply and Use) Ordinance 2003” (to be inserted in column 1);
- (b) “Ordinance 18/2003” (to be inserted in column 2);
- (c) “15(1) and (10)” (to be inserted in column 3);
- (d) “Chief Officer” (to be inserted in column 4);

(a) The Schedule was substituted by P.I. 99/2003.

- (e) “Minister of Agriculture, Natural Resources and Environment” (to be inserted in column 5).

6. There are inserted in columns 1 to 5 respectively immediately below the entries relating to the Old Peoples and Incapacitated Persons Homes Ordinance 1996 (which is mentioned in column 1) the following-

- (a) “Organic Production Ordinance 2003” (to be inserted in column 1);
 (b) “Ordinance 35/2003” (to be inserted in column 2);
 (c) “11(1)”
 17(1), (4) and (5)” (to be inserted in column 3);
 (d) “Chief Officer
 Chief Officer” (to be inserted in column 4);
 (e) “Department of Agriculture”,
 Minister of Agriculture, Natural Resources and Environment” (to be inserted in column 5).

7. There are inserted in columns 1 to 5 respectively immediately below the entries relating to the Propagating Material Ordinance 2000 (which is mentioned in column 1) the following-

- (a) “Protection and Welfare of Animals Ordinance 2001” (to be inserted in column 1);
 (b) “Ordinance 20/2001 as amended by Ordinance 40/2003” (to be inserted in column 2);
 (c) “11(1), 12, 15, 16, 17 and 21” (to be inserted in column 3);
 (d) “Chief Officer” (to be inserted in column 4);
 (e) “Director, Department of Veterinary Services” (to be inserted in column 5).

8. The entries relating to the Value Added Tax Ordinance 2001 (which is mentioned in column 1) are amended as follows –

- (a) for the words in column 2 there are substituted the words “Ordinance 10/2001 as amended by Ordinances 16/2002, 36/2002, Public Instrument 18/2003 and Ordinance 38/2003”; and
 (b) in column 3 -
 (i) the words “52, 53(4), (5) and (6)” are deleted,
 (ii) for “42(1)” there is substituted “42”, and
 (iii) after the words “51(1), (2), (3), (5) and (7),” there are inserted the words “52, 53(4), (5) and (6),”.

9. For the words in column 2 of the entries relating to the Food Hygiene Regulations 2002 (which are mentioned in column 1) there are substituted the words “P.I. 76/2002 as amended by P.I. 102/2003”.
