**THE POWERS AND DUTIES (OFFICERS OF THE
REPUBLIC OF CYPRUS) ORDINANCE 2002**

(Ordinance 12 of 2002 as amended by Public Instruments 98 of
2003 and 24 of 2004)

ORDER MADE UNDER SECTION 12

In exercise of the powers conferred upon him by section 12 of the Powers and Duties (Officers of the Republic of Cyprus) Ordinance 2002, and of all other powers enabling him in that behalf, the Administrator hereby makes the following Order:—

1. This Order may be cited as the Powers and Duties (Officers of the Republic of Cyprus) Ordinance 2002 (Variations to Schedule) (No. 2) Order 2004.

2.—(1) The Schedule to the Powers and Duties (Officers of the Republic of Cyprus) Ordinance 2002(a) is amended in accordance with paragraphs 3 to 12 below.

(2) In paragraphs 3 to 11 below—

(a) references to column 1 shall be construed as references to the columns headed “SHORT TITLE OF ORDINANCE” in the Schedule referred to in sub-paragraph (1) above; and

(b) references to column 2 shall be construed as references to the columns headed “REFERENCE” in that Schedule.

3. Immediately below the entries relating to the Animal Feeding Stuffs and Animal Feeding Stuff Additives (Control of Quality, Supply and Use) Ordinance 2003 (which is mentioned in column 1) there are inserted the following words—

(a) in column 1, the words “Animal Foodstuffs Hygiene Ordinance 2004”; and

(b) in column 2, the words “Ordinance 2/2004”.

4. Immediately below the entries made by paragraph 3 above relating to the Animal Foodstuffs Hygiene Ordinance 2004 there are inserted the following words—

(a) in column 1, the words “Animal Health Ordinance 2002”; and

(b) in column 2, the words “Ordinance 5/2002”.

5. Immediately below the entries relating to the Civil Procedure Ordinance (which is mentioned in column 1) there are inserted the following words—

(a) in column 1, the words “Classification of Wood in the Rough Ordinance 2004”; and

(b) in column 2, the words “Ordinance 5/2004”.

6. The entries relating to the Contagious Diseases (Animals) Ordinance 1988 (which is mentioned in column 1) are omitted.

(a) The Schedule was substituted by P.I. 98/2003 and further amended by P.I. 24/2004.

7. In column 2, for the entry relating to the Health and Safety at Work Ordinance 1999 (which is mentioned in column 1) there are substituted for the words “Ordinance 6/1999” the words “Ordinance 6/1999 as amended by Ordinance 42/2003”.

8. Immediately below the entries relating to the Mass Dismissals Ordinance 2003 (which is mentioned in column 1) there are inserted the following words—

(a) in column 1, the words “Meat Hygiene Ordinance 2004”,
and

(b) in column 2, the words “Ordinance 3/2004”.

9. Immediately below the entries relating to the Places of Entertainment Ordinance 1999 (which is mentioned in column 1) there are inserted the following words –

(a) in column 1, the words “Plant (Phytosanitary Measures) Ordinance 2004”; and

(b) in column 2, the words “Ordinance 8/2004”.

10. The entries relating to the Plant Diseases and Pests (Prevention and Control) Ordinance (which is mentioned in column 1) are omitted.

11. Immediately below the entries relating to the Poultrymeat (Specifications for the Production, Grading, Marking and Trading of Poultrymeat) Ordinance 2002 (which is mentioned in column 1) there are inserted the following words—

(a) in column 1, the words “Promotion of Renewable Sources of Energy and Conservation of Energy Ordinance 2004”;
and

(b) in column 2, the words “Ordinance 6/2004”.
