

No. 9**THE FIXED PENALTY ORDINANCE 1998**

(Ordinance 5 of 1998 as amended by Ordinances 14 of 2001 and 26 of 2003 and by Public Instruments No. 15 of 2002, 30 of 2002, 94 of 2003 and 132 of 2004)

REGULATIONS MADE UNDER SECTION 9.

In exercise of the powers vested in him by section 9 of the Fixed Penalty Ordinance 1998⁽¹⁾, the Administrator of the Sovereign Base Areas of Akrotiri and Dhekelia hereby makes the following Regulations:—

Citation

1. These Regulations may be cited as the Fixed Penalty Regulations 2005.

Form of Fixed Penalty Notice

2. The form of the notice which a Police Officer may issue and serve under section 3(1) or 3(2) of the Fixed Penalty Ordinance 1998, or which an Area Officer or any authorised member of his staff may issue and serve under section 3(2) of that Ordinance, shall be as set out in Schedule 1 to these Regulations.

Form of receipt

3. The form of the receipt which must be issued by a person to whom a fixed penalty has been paid under the provisions of section 5 of the Fixed Penalty Ordinance 1998 shall be as set out in Schedule 2 to these Regulations.

Revocation

4. The Fixed Penalty Regulations 1999 are revoked.
