
**PROTECTION AND MANAGEMENT OF GAME AND WILD BIRDS
(TEMPORARY GAME RESERVES) ORDER 2008**

The Chief Officer makes the following Order in exercise of his powers under section 43 of the Protection and Management of Game and Wild Birds Ordinance 2004(a).

Citation, commencement and expiry

1. (1) This Order may be cited as the Protection and Management of Game and Wild Birds (Temporary Game Reserves) Order 2008.

(2) This Order comes into force on the day on which it is published in the Gazette and expires on 1st March 2009.

Temporary game reserves

2. The following areas, described in articles 3 to 10 and so far as they are not otherwise game reserves, are temporary game reserves for the periods specified (both dates included):-

- (a) the Southern Akrotiri-SBA temporary game reserve for all periods which are game seasons from 31st August 2008 to 28th February 2009;
- (b) the North-Eastern Akrotiri-SBA temporary game reserve for all periods which are game seasons from 31st August 2008 to 28th February 2009;
- (c) the Kolossi temporary game reserve for all periods which are game seasons from 31st August 2008 to 3rd January 2009;
- (d) the Southern Kouris temporary game reserve from 31st August 2008 to 19th October 2008;
- (e) the North-Western Akrotiri-SBA temporary game reserve—
 - i. from 31st August 2008 to 19th October 2008, and
 - ii. on Mondays, Tuesdays, Thursdays, Fridays and Saturdays (except Thursday 26th February 2009, Friday 27th February 2009 and Saturdays 14th, 21st and 28th February 2009), from 2nd November 2008 to 28th February 2009, provided such days fall within a game season; and
- (f) the Dhekelia-SBA temporary game reserve, for all periods which are game seasons from 31st August 2008 to 28th February 2009;

Southern Akrotiri-SBA temporary game reserve

3. The Southern Akrotiri-SBA temporary game reserve is the area which is marked in orange on the map labelled SBA/AOA/TGR(2008), signed by me on 4th August 2008 and deposited for public inspection, during normal working hours, at the Area Office Akrotiri.

North-Eastern Akrotiri-SBA temporary game reserve

4. The North-Eastern Akrotiri-SBA temporary game reserve is the area which is marked in yellow on the map labelled SBA/AOA/TGR(2008), signed by me on 4th August 2008 and deposited for public inspection, during normal working hours, at the Area Office Akrotiri.

Kolossi temporary game reserve

5. The Kolossi temporary game reserve/hunting area is the area which is marked in red on the map

labelled SBA/AOA/TGR(2008), signed by me on 4th August 2008 and deposited for public inspection, during normal working hours, at the Area Office Akrotiri.

Southern Kouris temporary game reserve

6. The Southern Kouris temporary game reserve/hunting area is the area which is marked in green on the map labelled SBA/AOA/TGR(2008), signed by me on 4th August 2008 and deposited for public inspection, during normal working hours, at the Area Office Akrotiri.

North-Western Akrotiri-SBA temporary game reserve

7. The North-Western Akrotiri-SBA temporary game reserve/hunting area is the area which is marked in blue on the map labelled SBA/AOA/TGR(2008), signed by me on 4th August 2008 and deposited for public inspection, during normal working hours, at the Area Office Akrotiri.

Dhekelia-SBA temporary game reserve

8. The Dhekelia-SBA temporary game reserve is all of the Dhekelia Sovereign Base Area, except for the Dhekelia Game Reserve designated by Public Instrument 58 of 1969, the Ormidhia-Avgorou-Akhna-Xylotymbou hunting area and the Xylotymbou-Ormidhia hunting area set out in articles 9 and 10 respectively.

Ormidhia-Avgorou-Akhna-Xylotymbou hunting area

9. The Ormidhia-Avgorou-Akhna-Xylotymbou hunting area is the area which is marked in green on the map labelled SBA/AOD/HA(2008) signed by me on 4th August 2008 and deposited for public inspection, during normal working hours, at the Area Office Dhekelia.

Xylotymbou-Ormidhia hunting area

10. The Xylotymbou-Ormidhia hunting area is the area which is marked in blue on the map labelled SBA/AOD/HA(2008), signed by me on 4th August 2008 and deposited for public inspection, during normal working hours, at the Area Office Dhekelia.
