
**AKROTIRI VILLAGE (SPECIAL PROVISIONS) (APPOINTMENT OF CHAIRPERSON
AND SUPERVISING OFFICER) NOTICE 2008**

The Administrator makes the following notice in exercise of his powers under sections 2 and 4 of the Akrotiri Village (Special Provisions) Ordinance 1966(a), after consultation with the appropriate authorities of the Republic -

Citation and Commencement

1. This Notice may be cited as the Akrotiri Village (Special Provisions) (Appointment of Chairperson and Supervising Officer) Notice 2008 and comes into force on the day on which it is published in the Gazette.

Interpretation

2. In this Notice –

“the Special Committee” means the Special Committee for the administration and control of specified property in Akrotiri village established under section 4 of the Akrotiri Village (Special Provisions) Ordinance 1966.

Revocation and Appointment of Chairperson

3. (1) The appointment of Mrs Stala Constantinou as Chairperson of the Special Committee is revoked.

(2) Mr Haris Zachariou, Assistant District Officer in the District Office of Limassol, is appointed as Chairperson of the Special Committee until 16 July 2009.

Appointment of Supervising Officer

4. Mr Haris Zachariou, Assistant District Officer in the District Office of Limassol, is appointed as Supervising Officer.

Revocations

5. Public Instruments 42/95 (Constitution of Special Committee) and 30/01 (Appointment of Supervising Officer) are revoked.

EXPLANATORY NOTE
(This note is not part of the Regulations)

Introduction

1. This explanatory note relates to the Akrotiri Village (Special Provisions) (Appointment of Chairperson and Supervising Officer) Notice 2008. It has been prepared by the Office of the Attorney General and Legal Adviser in order to assist the reader of the Notice. It does not form part of the Notice.

2. This note should be read in conjunction with the Notice. It is not, and is not meant to be, a comprehensive description of the Notice.

Particular points

3. Section 4 of the Akrotiri Village (Special Provisions) Ordinance 1966 (“the Ordinance”) provides for the Administrator to nominate two officers of the Republic as members of the Special Committee for the administration and control of specified property in Akrotiri Village (“the Committee”) and to appoint one of those two officers as Chairperson.

4. By Public Instrument 103/04, the Administrator appointed Mrs Stala Constantinou and Mr Costas Manoli, as Chairperson and member respectively. The full constitution of the Committee, including those two appointments, was notified by Public Instrument 104/04.

5. This Notice revokes the appointment of Mrs Constantinou as Chairperson, and appoints Mr Haris Zachariou in her place. The rest of the Committee remain in post, so Public Instruments 103/04 and 104/04 remain in force subject to the replacement of Mrs Constantinou by Mr Zachariou.

6. Mr Zachariou also replaces Mrs Constantinou as the Supervising Officer appointed under Section 2 of the Ordinance. Public Instrument 30/01, which appointed Mrs Constantinou, is revoked.

7. The opportunity has also been taken to revoke Public Instrument 42/95, which appointed a previous Committee holding office from 7 June 1995 to 6 June 1998, and which is now obsolete
