**LAND ACQUISITION (SANCTION OF ACQUISITION) (AKROTIRI LAND  
CONSOLIDATION AREA) NOTIFICATION 2012**

---

In exercise of the powers under section 7 of the Land Acquisition Ordinance(a), the Administrator, having approved the plans and particulars submitted to him under section 6 of that Ordinance and considering it expedient, having had regard to all of the circumstances of the case, that the land referred to in article 2 should be acquired, makes the following notification:

**Citation and commencement**

1. This notification may be cited as the Land Acquisition (Sanction of Acquisition) (Akrotiri Land Consolidation Area) Notification 2012 and comes into force on the day it is published in the Gazette.

**Sanction of acquisition**

2. The acquisition of the private land specified in the Schedule is sanctioned for the construction of public rural roads serving the area known as the Akrotiri/1 Land Consolidation Area, within the Akrotiri Sovereign Base Area.

**Schedule**

The land specified is the private immovable property listed below, which is shown shaded in red on the three plans, marked SBA/AOA/CA/AK1LCA/P1, SBA/AOA/CA/AK1LCA/P2 and SBA/AOA/CA/AK1LCA/P3, which are available for inspection at the Area Office Akrotiri, during normal working hours.
