FIXED PENALTY (AMENDMENT OF SCHEDULE TO ORDINANCE)(NO.2) ORDER 2012

The Administrator makes the following Order in exercise of the powers under section 9(2) of the Fixed Penalty Ordinance 2010(a)

Citation and commencement

1. This Order may be cited as the Fixed Penalty (Amendment of Schedule to Ordinance) (No. 2) Order 2012 and comes into force on 1 January 2013.

Amendment to Schedule 1 to the Fixed Penalty Ordinance 2010

2. Schedule 1 to the Fixed Penalty Ordinance 2010 is amended by repealing serial number 61 and substituting—

EXPLANATORY NOTE

(This note is not part of the Order)

1. This explanatory note relates to the Fixed Penalty (Amendment of Schedule to Ordinance) (No. 2) Order 2012. It has been prepared by the Office of the Attorney General and Legal Adviser in order to assist the reader of the Order.

2. The Order amends Schedule 1 to the Fixed Penalty Ordinance 2010 by changing the determination of the amount of a fixed penalty which may be imposed by a police officer for a speeding offence. This reflects the amendment to Republican law made by the Fixed Penalty Amendment Law 2012 (No. 90 (I) 2012).
