**EXPORT OF CURRENCY (RESTRICTIVE MEASURES) (CONTINUATION) (NO. 8)
ORDER 2013**

The Chief Officer makes the following Order in exercise of the powers in section 2(3) of the Export of Currency (Restrictive Measures) (No. 5) Ordinance 2013(a).

Citation

1. This Order may be cited as the Export of Currency (Restrictive Measures) (Continuation) (No. 8) Order 2013.

Commencement

2. This Order comes into force at 11.59 pm on 1 October 2013.

Export of Currency (Restrictive Measures) (No. 5) Ordinance 2013 continues in force

3. The Export of Currency (Restrictive Measures) (No. 5) Ordinance 2013 continues in force and expires at the end of 31 October 2013.

Export of Currency (Restrictive Measures) (Continuation) (No. 7) Order 2013 revoked

4. The Export of Currency (Restrictive Measures) (Continuation) (No. 7) Order 2013(b) is revoked.

EXPLANATORY NOTE

(This note does not form part of the Order)

1. This explanatory note relates to the Export of Currency (Restrictive Measures) (Continuation) (No. 8) Order 2013 (the “Order”). It has been prepared by the Office of the Attorney-General and Legal Adviser in order to assist the reader of the Order.
2. The Order provides that the Export of Currency (Restrictive Measures) (No. 5) Ordinance 2013 should continue in force until the end of 31 October 2013.
