EXPORT OF CURRENCY (RESTRICTIVE MEASURES) (CONTINUATION) ORDER 2014

The Chief Officer makes the following Order in exercise of the powers in section 2(3) of the Export of Currency (Restrictive Measures) (No. 5) Ordinance 2013(a).

Citation

1. This Order may be cited as the Export of Currency (Restrictive Measures) (Continuation) Order 2014.

Commencement

2. This Order comes into force at 11.59 pm on 31 January 2014.

Export of Currency (Restrictive Measures) (No. 5) Ordinance 2013 continues in force

3. The Export of Currency (Restrictive Measures) (No. 5) Ordinance 2013 continues in force and expires at the end of 31 March 2014.

Export of Currency (Restrictive Measures) (Continuation) (No. 10) Order 2013 revoked

4. The Export of Currency (Restrictive Measures) (Continuation) (No. 10) Order 2013(b) is revoked.
