**SEASHORE PROTECTION (LOCAL SEASHORE  
PLAN) (ORMIDHIA) NOTICE 2015**

---

The Administrator makes the following Notice in exercise of the power in section 16(4) of the Seashore Protection Ordinance 2013(a).

WHEREAS—

(1) under section 16(1) and (2) of the Seashore Protection Ordinance 2013 (“the Ordinance”) the local seashore committee of Ormidhia Community Council has published a draft plan in the Gazette on 10 June 2015 (the “draft plan”);

(2) the plan will replace the plan published in the Gazette on 28 March 2013;

(3) the draft plan shows the area of seashore within the Ormidhia Community Council’s area where it is proposed that 160 sun beds and 80 beach umbrellas, one movable kiosk, one movable storage facility, one movable structure containing toilets and changing rooms, two movable showers and one movable structure to be used as a lifeguard tower (“the public amenities”) are to be placed;

(4) pursuant to section 16(3) of the Ordinance, the draft plan was published in the Gazette on 10 June 2015 together with a notification inviting representations to be made concerning the draft plan by 12 July 2015; and

(5) no representations were received by 12 July 2015.

**Citation and commencement**

1.—This Notice may be cited as the Seashore Protection (Local Seashore Plan) (Ormidhia) Notice 2015.

**Interpretation**

2. The “plan” is the local seashore plan prepared by the local seashore committee of Ormidhia Community Council and is attached to the Schedule.

**Approval**

3. The Administrator approves the plan without modification.

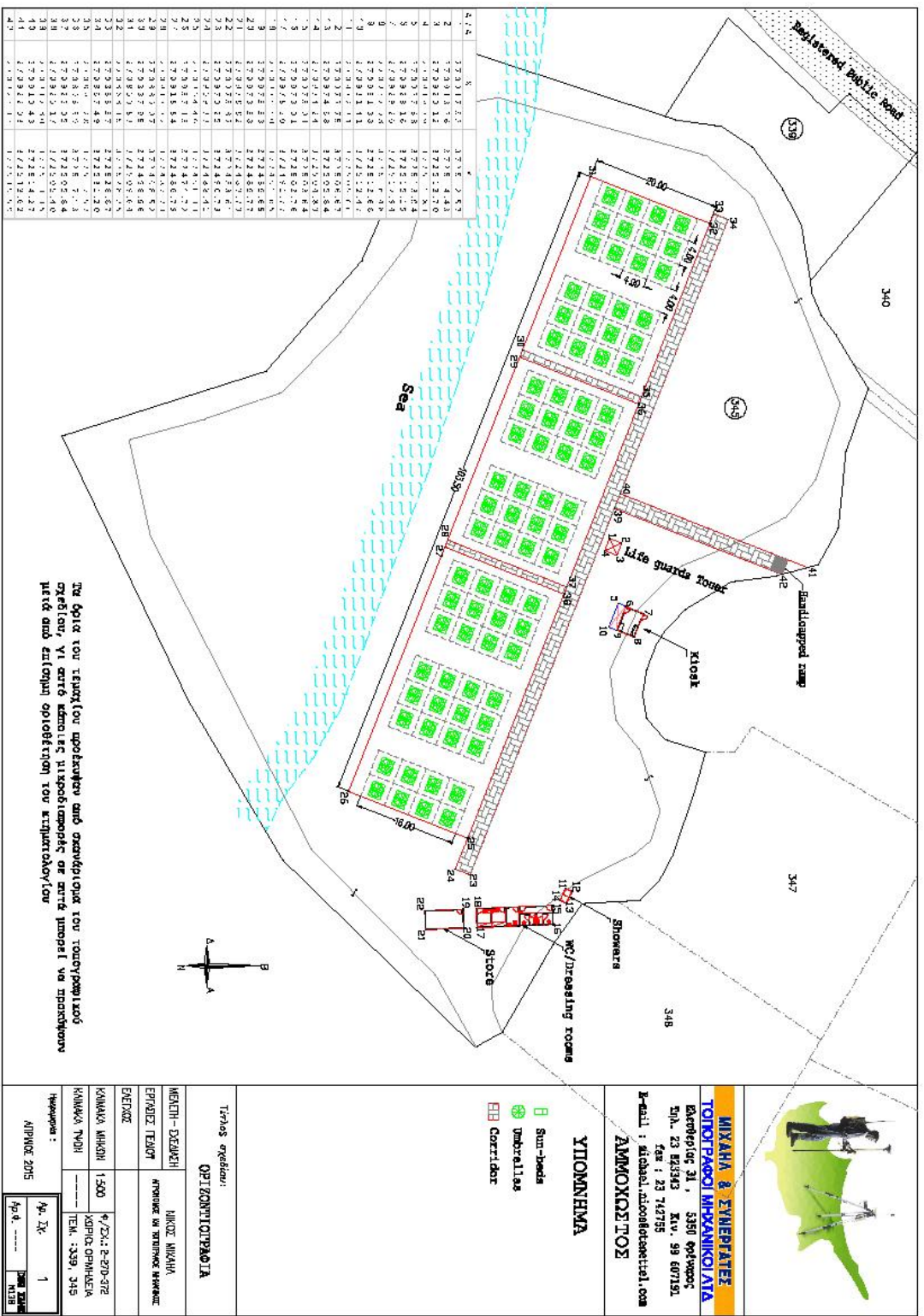
**Commencement**
