
G A M E A N D W I L D B I R D S (H U N T I N G)
(A M E N D M E N T) R E G U L A T I O N S 2 0 1 8

The Chief Officer makes the following Regulations in exercise of the powers in sections 17(1)(e) and 17(1)(fa) of the Game and Wild Birds Ordinance 2008(a):

Citation, commencement and expiry

1.—(1) These Regulations may be cited as the Game and Wild Birds (Hunting) (Amendment) Regulations 2018.

(2) These Regulations come into force on 14 November 2018.

(3) These Regulations expire on 1 March 2019.

Amendments to the Game and Wild Birds (Hunting) Regulations 2018

2. The Game and Wild Birds (Hunting) Regulations 2018 (the “2018 Regulations”) are amended in accordance with these Regulations.

Amendment to regulation 2 of the 2018 Regulations

3. For regulation 2 (interpretation) substitute—

“2. In these Regulations, “the Autumn-Winter Game Season 18-19” means the period from 4 November 2018 to 28 February 2019 (both dates included), except 25 December 2018 and 1 January 2019.”.

Amendment to regulation 4 of the 2018 Regulations

4. For regulation 4 (permitted periods for hunting for certain species) substitute—

“4. During the Autumn-Winter Game Season 18-19, the holder of a game licence must not shoot, kill, capture or pursue a species specified in column 1 of the table in Schedule 2 except within the period, and on the days, specified in the corresponding row of column 2 of that table.”.

Amendment to regulation 5 of the 2018 Regulations

5. For regulation 5 (hunting accompanied by dogs) of the 2018 Regulations substitute—

(a) Ordinance 21/2008 as amended by Ordinance 10/2018.

“5.—(1) The holder of a game licence who shoots, kills, captures or pursues game must not be accompanied by a dog, except—

a) during the Autumn-Winter Game Season 18-19, on any Wednesday or Sunday from 4 November 2018 to 30 December 2018 (both dates included),

b) within any area in the Sovereign Base Areas of Akrotiri and Dhekelia that is neither a general game reserve, under the Game and Wild Birds (General Game Reserves) Order 2017(a), nor a temporary game reserve, under the Game and Wild Birds (Temporary Game Reserves) Order 2018(b).

(2) A person carrying out any activities pursuant to subsection (1) must not, in any event, be accompanied by more than 4 hunting dogs.”.

Amendment to Schedule 2 of the 2018 Regulations

6. For “Regulation 4(2)” substitute “Regulation 4”.

Omit Schedules 1 and 3 of the 2018 Regulations

7. Omit Schedules 1 and 3 of the 2018 Regulations.

EXPLANATORY NOTE

(This note is not part of the Regulations)

1. This explanatory note relates to the Game and Wild Birds (Hunting) (Amendment) Regulations 2018. It has been prepared by the Office of the Attorney General and Legal Adviser in order to assist the reader of the Regulations, and does not form part of the Regulations.
2. Regulation 5 sets out the maximum number of hunting dogs that a person may be accompanied by in prescribed areas, and on prescribed days, during the Autumn-Winter Game Season 18-19.
