
**LOCAL AFFAIRS (GENERAL) BYE-LAWS OF THE
COMMUNITY COUNCIL OF TSERKEZ
TSIFTLIK (AMENDMENT) 2019**

The Community Council of **Tserkez Tsiftlik**, with the approval of the Chief Officer, makes these Bye-Laws in exercise of the powers conferred by section 8(a) of the Overlapping Communities Ordinance (a).

Citation and commencement

- 1.—(1) These Bye-Laws may be cited as the Local Affairs (General) Bye-Laws of the Community Council of **Tserkez Tsiftlik** (Amendment) 2019.
- (2) These Bye-Laws come into force on 1 January 2020.

Amendment of the Local Affairs (General) Bye-Laws of the Community Council of Tserkez Tsiftlik 2003

2. The Local Affairs (General) Bye-Laws of the Community Council of **Tserkez Tsiftlik** 2003(b) are amended as follows.

Amendment of Bye-Law 2

3. At the beginning of Bye-Law 2, insert “Subject to Bye-Laws 3 to 5,”.

Insertion of Bye-Laws 3 to 5

4. After Bye-Law 2, insert—

“Modifications of the Bye-Laws of Episkopi

3. The Local Affairs (General) Bye-Laws of the Community Council of Episkopi 2003 are subject to the modifications set out in Bye-Laws 4 and 5.

Modification of Bye-Law 101(4)

4. In Bye-Law 101(4) (refuse receptacles), for “106”, substitute “104”.

Modification of Bye-Law 104

5. In Bye-Law 104 (fees for removal of refuse), for the text after “refuse” to the end, substitute—

“(a) for residential premises, a sum not exceeding €250,

- (b) for shops, stores or coffee shops, a sum not exceeding €854,
- (c) for guest houses, inns, tourist apartments, other tourist accommodation (not being hotels), places of entertainment or restaurants, a sum not exceeding €6,832,
- (d) for hotels, a sum not exceeding €17,081, and
- (e) for other premises, a sum not exceeding €13,665.”.”.

EXPLANATORY NOTE

(This note is not part of the Bye-Laws)

1. This explanatory note relates to the Local Affairs (General) Bye-Laws of the Community Council of Tserkez Tsiftlik (Amendment) 2019 (“the Bye-Laws”). It has been prepared by the Office of the Attorney General and Legal Adviser in order to assist the reader of the Order. It does not form part of the Bye-Laws.
2. Bye-Law 4 amends the Local Affairs (General) Bye-Laws of the Community Council of Tserkez Tsiftlik 2003. These generally apply the Local Affairs (General) Bye-Laws of the Community Council of Episkopi 2003 (“the Episkopi Bye-Laws”) in the Areas of the Tserkez Tsiftlik Community. Bye-Law 4 modifies that application with regards to the fees to be charged for waste collection. The reference, in Bye-Law 101(4) of the Episkopi Bye-Laws, to the waste collection fees “mentioned in Bye-Law 106”, is changed to a reference to the fees “mentioned in Bye-Law 104”. Bye-Law 104 is modified, to change the maximum fees that the Council may charge for its waste collection services.
