QUARANTINE (PUBLIC HEALTH) (AMENDMENT) REGULATIONS 2020

The Administrator makes the following Regulations in exercise of the power under section 6 of the Quarantine Ordinance(a).

Citation and commencement

- **1.**—(1) These Regulations may be cited as the Quarantine (Public Health) (Amendment) Regulations 2020.
 - (2) These Regulations come into force on 1st March 2020.

Amendment of the Quarantine (Public Health) Regulations

- **2.**—(1) The Quarantine (Public Health) Regulations(**b**) are amended as follows.
- (2) In regulation 2, for "any disease mentioned in the Schedule hereto", substitute "any dangerous infectious disease".
- (3) In regulation 3, for "any of the disease mentioned in the Schedule hereto", substitute "any dangerous infectious disease".
- (4) In regulation 4, for "a disease mentioned in the Schedule", substitute "a dangerous infectious disease".
 - (5) In regulation 8, omit "mentioned in the Schedule hereto".
- (6) In regulation 10, for "a disease mentioned in the Schedule", substitute "a dangerous infectious disease.
- (7) In regulation 37(1)(a), for "a disease listed in the Schedule", substitute "a dangerous infectious disease".
 - (8) Omit the Schedule.
