QUARANTINE (MEASURES TO PREVENT THE SPREAD OF COVID-19) (NO.4) REGULATIONS 2020

The Administrator makes the following Regulations in exercise of the power under section 6(b), (c) and (d) of the Quarantine Ordinance(a).

Citation and commencement

- **1.**—(1) These Regulations may be cited as the Quarantine (Measures to Prevent the Spread of Covid-19) (No.4) Regulations 2020.
 - (2) These Regulations come into force on the day after the day on which they are made.

Price caps for certain products

2. Until 30 April 2020, no person may sell or offer for sale any of the products listed in the following table at a price above the relevant maximum price indicated in the table—

Suspension of activities

- **3.**—(1) Regulation 3 (suspension of activities) of the Quarantine (Measures to Prevent the Spread of Covid-19) (No.2) Regulations 2020(a) is amended as follows.
 - (2) At the end of paragraph (1)(q), delete "and", and at the end of paragraph (1)(r) insert—
 "; and
 - (s) internal vehicle cleaning services".
 - (3) After paragraph (1) insert—
 - "(1A) For the purposes of paragraph (1)(b), where, in an area adjacent to premises where food is being sold, seating is made available for the customers of the seller of that food, the food is not deemed to be sold for consumption off the premises in question, whether or not the seating is made available by that seller."
 - (4) In paragraph (3) for "and their families" substitute ", whether directly or through others".
 - (5) In paragraph (4), for "paragraph (5)" substitute "paragraphs (5) and (5A)"
 - (6) After paragraph (5) insert—
 - "(5A) A person may continue to provide hotel or tourist accommodation if the provision is in accordance with—
 - (a) an agreement between the hotel or accommodation provider and the government of the Republic; or

- (b) an agreement between the hotel or accommodation provider and a diplomatic mission of a state, or an international organisation, to accommodate foreign citizens who are hosted temporarily in the Republic in accordance with an international agreement.
- (5B) Paragraph (1)(b) does not prohibit food or drink to be sold as room service by a hotel or other accommodation provider authorised by paragraph (5A) to remain open."
- (7) At the end of paragraph (6) insert ", except remotely".
- (8) At the end of paragraph (7) insert ", except remotely".
- (9) After paragraph (7) add—
 - "(8) Subject to paragraph (9), until 30th April 2020, no person may provide tables and chairs at canteens at work places.
 - (9) Paragraph (8) does not apply on land occupied by the Crown in right of its Government of the United Kingdom."

Officers of bodies corporate

4.—(1) After regulation 6 of the Quarantine (Measures to Prevent the Spread of Covid-19) (No. 2) Regulations 2020(**a**), insert—

"Officers of bodies corporate

- 7.—(1) An officer of a body corporate must not—
 - (a) consent to or connive in a contravention of these Regulations by the body, or
 - (b) cause, by neglect, such a contravention to be committed.
- (2) In paragraph (1), "officer", in relation to a body corporate, means a director, manager, secretary or other similar officer of the body corporate."

Additional amendments to Quarantine (Measures to Prevent the Spread of Covid-19) (No.2) Regulations 2020

- **5.** The following provisions of the Quarantine (Measures to Prevent the Spread of Covid-19) (No.2) Regulations 2020 are deleted—
 - (a) regulation 4 (occupancy of public establishments); and
 - (b) regulation 5 (presence of employees).

Prohibition of exports of pharmaceutical products

- **6.**—(1) No person may take a pharmaceutical product outside the Areas, except where permitted by this regulation.
- (2) A person may take a pharmaceutical product from the Areas directly to a part of the Republic that is under the effective control of the government of the Republic.
- (3) A person may take a pharmaceutical product outside the Areas where authorised to do so by the Chief Officer.
 - (4) A person may take a pharmaceutical product outside the Areas if—
 - (a) the product (taking into account the amount taken) could be used within 72 hours following its removal from the Areas by any of the following—
 - (i) the person taking the product outside the Areas,
 - (ii) a close relative of that person, or

- (iii) a person under the age of 18 who is under that person's care or supervision, and
- (b) a reasonably prudent person would take the product with them for such a purpose.
- (5) A person may take a pharmaceutical product outside the Areas if the person has obtained it with a prescription.
- (6) The function of the Chief Officer under paragraph (3) is a general delegated function for the purpose of the Delegation of Functions to the Republic Ordinance 2007(a).
- (7) In this regulation, "pharmaceutical product" has the meaning as in the Quarantine (Measures to prevent the spread of the coronavirus COVID-19) (No. 11) Order 2020(**b**).

EXPLANATORY NOTE

(This note is not part of the Regulations)

- **1.** This explanatory note relates to the Quarantine (Measures to Prevent the Spread of Covid-19) (No. 4) Regulations 2020 ("the Regulations"). It has been prepared by the Office of the Attorney General and Legal Adviser in order to assist the reader of the Notice. It does not form part of the Regulations
- **2.** The Regulations make provisions which are substantially similar to Orders made in the Republic under the Quarantine Law.
 - **3.** Regulation 2 imposes maximum retail and wholesale prices for certain products.
- **4.** Regulations 3 to 5 make amendments to the Quarantine (Measures to Prevent the Spread of Covid-19) (No.2) Regulations 2020 ("the No.2 Regulations"). The amendment made by regulation 4 provides that a director or similar officer of a body corporate is prohibited from contributing in various ways to a contravention of the No.2 Regulations by the body corporate. A director or similar officer who breaches this prohibition personally commits an offence under the Quarantine Ordinance. Regulation 5 deletes two provisions from the No.2 Regulations, because those same provisions now appear in the Protection of Public Health (Covid-19) Ordinance 2020.
- **5.** Regulation 6 prevents any person from exporting pharmaceutical products from the Areas, subject to certain limited exceptions.
