# QUARANTINE (MEASURES TO PREVENT THE SPREAD OF COVID-19) (NO.2) (AMENDMENT) REGULATIONS 2020

The Administrator makes the following Regulations in exercise of the power under section 6(b), (c) and (d) of the Quarantine Ordinance(a).

## Citation and commencement

- **1.**—(1) These Regulations may be cited as the Quarantine (Measures to Prevent the Spread of Covid-19) (No.2) (Amendment) Regulations 2020.
  - (2) These Regulations come into force on Monday 13 April 2020.

# Amendment of the Quarantine (Measures to Prevent the Spread of Covid-19 (No.2) Regulations 2020

**2.** The Quarantine (Measures to Prevent the Spread of Covid-19 (No.2) Regulations 2020(**b**) are amended as follows.

# Amendment of section 3 (suspension of activities)

- 3. In regulation 3—
  - (a) in paragraph (1) omit "Until 13th April 2020, 5.59pm, inclusive,";
  - (b) in paragraph (6) omit "Until 13th April 2020, 5.59pm, inclusive,"; and
  - (c) in paragraph (7) omit "Until 13th April 2020, 5.59pm, inclusive,".

## Amendment of section 6 (wider public sector employees and workers)

**4.** In regulation 6, omit paragraph (1).

## EXPLANATORY NOTE

(This note is not part of the Regulations)

- 1. This explanatory note relates to the Quarantine (Measures to Prevent the Spread of Covid-19) (No. 2) (Amendment) Regulations 2020 ("the Regulations"). It has been prepared by the Office of the Attorney General and Legal Adviser in order to assist the reader of the Notice. It does not form part of the Regulations
- **2.** The Regulations amend the Quarantine (Measures to Prevent the Spread of Covid-19) (No. 2) Regulations 2020 ("the No.2 Regulations"). They remove the expiry date in regulations 3(1), 3(6), 3(7) and 6 of the No. 2 Regulations. This means that these provisions will remain in force until the date on which the No. 2 Regulations expire, which is 30 April.
