
**QUARANTINE (MEASURES TO PREVENT THE
SPREAD OF COVID-19) (NO. 4) (AMENDMENT)
REGULATIONS 2020**

The Administrator makes the following Regulations in exercise of the power under section 6(b), (c) and (d) of the Quarantine Ordinance (a).

Citation and commencement

1.—(1) These Regulations may be cited as the Quarantine (Measures to Prevent the Spread of Covid-19) (No.4) (Amendment) Regulations 2020.

(2) These Regulations come into force on the day after the day on which they are made.

Amendment of the Quarantine (Measures to Prevent the Spread of Covid-19) (No.4) Regulations 2020

2.—(1) The Quarantine (Measures to Prevent the Spread of Covid-19) (No.4) Regulations 2020(b) are amended as follows.

(2) For regulation 2, substitute—

“Price caps for certain products

2.—(1) Until 17 May 2020, no person may sell or offer for sale any of the products listed in the following table at a price above the relevant maximum price indicated in the table—

EXPLANATORY NOTE

(This note is not part of the Regulations)

1. This explanatory note relates to the Quarantine (Measures to Prevent the Spread of Covid-19) (No.4) (Amendment) Regulations 2020 (“the Regulations”). It has been prepared by the Office of the Attorney General and Legal Adviser in order to assist the reader of the Regulations. It does not form part of the Regulations.
2. The Regulations make provisions which are substantially similar to paragraphs 2(i), 2(j) and (k) of the Quarantine (Measures to prevent the spread of the coronavirus COVID-19) (No. 16) Order 2020 of the Republic, P.I. 169/2020, published in Supplement III(I) of Gazette No. 5248.
3. These Regulations replace the maximum retail and wholesale prices for products as introduced by the Quarantine (Measures to Prevent the Spread of Covid-19) (No.4) Regulations 2020, and introduce a maximum price to purchase a molecular test for Covid-19.
