SEA BATHERS (PROTECTION) (SEA BATHING AREAS) (AMENDMENT) ORDER 2020

The Chief Officer makes this order in exercise of the powers conferred by section 4 of the Sea Bathers (Protection) Ordinance $2014(\mathbf{a})$.

Citation

1. This Order may be cited as the Sea Bathers (Protection) (Sea Bathing Areas) (Amendment) Order 2020.

Commencement

2. This Order comes into force on 9 May 2020.

Amendment of the Sea Bathers (Protection) (Sea Bathing Areas) Order 2014

3. The Sea Bathers (Protection) (Sea Bathing Areas) Order 2014(b) is amended as follows.

Amendment of regulation 3 (period of application)

4. For regulation 3(2), substitute—

"(2) In relation to the sea bathing areas specified in paragraphs 5 and 18 of the Schedule, this Order applies each year from 1 April to 30 November.".

Amendment of the Schedule (description of the parts of the sea – sea bathing areas)

5.—(1) The Schedule is amended as follows.

(2) For paragraph 8 (Lady's Mile Beach), substitute-

"8. Lady's Mile Beach—

- (a) the line joining the position latitude 34°38.45'N, longitude 33°00.66'E ("point A") to the position latitude 34°38.43'N, longitude 33°00.72'E ("point B");
- (b) the line joining point B to the position latitude 34°36.01'N, longitude 33°00.50'E ("point C");
- (c) the line joining point C to the position latitude 34°35.99'N, longitude 33°00.43'E ("point D");
- (d) the line joining point A to point D; and

(e) the waters inshore, from and perpendicular to the line joining point A to point D, to the waterline.".

(3) For paragraph 11 (Snug Beach), substitute—

"11. Snug Beach—

- (a) the line joining the position latitude 34°35.775'N, longitude 33°00.584'E ("point A") to the position latitude 34°35.684'N, 33°00.633'E ("point B");
- (b) the line joining point B to the position latitude 34°35.667'N, longitude 33°00.611'E ("point C");
- (c) the line joining point A to point C; and
- (d) the waters inshore from, and perpendicular to the line joining point A to point C, to the waterline.".

EXPLANATORY NOTE

- 1. This explanatory note relates to the Sea Bathers (Protection) (Sea Bathing Areas) (Amendment) Order 2020 ("the Order") It has been prepared by the Office of the Attorney General and Legal Adviser in order to assist the reader of the Order. It does not form part of the Order
- **2.** This note should be read in conjunction with the Order. It is not, and is not meant to be, a comprehensive description of it.
- **3.** The Order is made by the Chief Officer under the Sea Bathers (Protection) Ordinance 2014, which confer powers to specify sea bathing areas that are reserved for the use of sea bathers for a specified period each year. It amends the Sea Bathers (Protection) (Sea Bathing Areas) Order 2014 ("the principal Order").
- 4. *Paragraph 4* of the Order changes the time during which the principal Order applies in relation to Dhekelia Water Sports Club Beach.
- 5. *Paragraph 5* of the Order amends the coordinates of the bathing areas at Lady's Mile Beach and Snug Beach set out in the Schedule to the principal Order.
