The Administrator makes the following Regulations in exercise of the power under section 6(b), (c) and (d) of the Quarantine Ordinance(a).

Citation and commencement

1.—(1) This Order may be cited as the Quarantine (Measures to Prevent the Spread of Covid-19) (No.6) Regulations 2020.

(2) This Order comes into force on the day after the day on which it is made by the Administrator.

Amendment of the Quarantine (Measures to Prevent the Spread of Covid-19) (No.2) Regulations 2020

2.—(1) The Quarantine (Measures to Prevent the Spread of Covid-19) (No.2) Regulations 2020(b) are amended as follows.

(2) In regulation 3(1)(l), insert at the beginning “Subject to section 8(5) of the Protection of Public Health (Covid-19) Ordinance 2020,”.

Amendment of the Quarantine (Measures to Prevent the Spread of Covid-19) (No.4) Regulations 2020

3.—(1) The Quarantine (Measures to Prevent the Spread of Covid-19) (No.4) Regulations 2020(c) are amended as follows.

(2) In regulation 2 (Price caps for certain products) —

- (a) in the table at paragraph (1), in the category of “Simple Surgical Masks”, for “27.37 per 50 pieces” substitute “31.00 per 50 pieces”;
- (b) in paragraph (2) for “€110.00” substitute “€85.00”.

EXPLANATORY NOTE

(This note is not part of the Regulations)

1. This explanatory note relates to the Quarantine (Measures to Prevent the Spread of Covid-19) (No.6) Regulations 2020 (“the Regulations”). It has been prepared by the Office of the Attorney General and Legal Adviser in order to assist the reader of the Regulations. It does not form part of the Regulations.
2. The Regulations amend the Quarantine (Measures to Prevent the Spread of Covid-19)(No.2) Regulations 2020 and Quarantine (Measures to Prevent the Spread of Covid-19)(No.4) Regulations 2020. Regulation 2 of the Regulations provides an exception to the suspension of activities and regulation 3 imposes maximum retail and wholesale prices for certain products.
