
**GAME AND WILD BIRDS (TEMPORARY GAME
RESERVES) ORDER 2020**

The Chief Officer makes the following Order in exercise of the power in section 32 of the Game and Wild Birds Ordinance 2008(a):

Citation, commencement and expiry

1.—(1) This Order may be cited as the Game and Wild Birds (Temporary Game Reserves) Order 2020.

(2) This Order comes into force on 22 August 2020.

(3) This Order expires on 1 March 2021.

Interpretation

2. In this Order—

(a) the “Akrotiri TGR map” is the map in Schedule 1;

(b) the “Dhekelia TGR map” is the map in Schedule 2.

Temporary game reserves

3. The following areas are designated as temporary game reserves for the following days or periods—

(a) The area coloured orange and labelled H1 on the Akrotiri TGR map—

(i) on 23 August 2020;

(ii) from 30 August 2020 to 30 October 2020 (both dates included);

(b) the area coloured red and labelled H2 on the Akrotiri TGR map—

(i) on 23 August 2020;

(ii) from 30 August 2020 to 30 October 2020 (both dates included);

(iii) from 1 November 2020 to 29 December 2020 (both dates included), except 25 December 2020;

(c) the area coloured brown and labelled H3 on the Akrotiri TGR map—

(i) on 23 August 2020;

(ii) from 30 August 2020 to 30 October 2020 (both dates included);

(iii) all Mondays, Tuesdays, Thursdays, Fridays and Saturdays from 2 November 2020 to 26 February 2021 (both dates included), except Friday 25 December 2020 and Friday 1 January 2021;

(a) Ordinance 21/2008. There have been amendments to Ordinance 21/2008 which are not relevant to this Order.

- (d) the area coloured yellow and labelled H4 on the Akrotiri TGR map—
 - (i) on 23 August 2020;
 - (ii) from 30 August 2020 to 30 October 2020 (both dates included);
 - (iii) all Mondays, Tuesdays, Thursdays, Fridays and Saturdays from 2 November 2020 to 26 February 2021 (both dates included), except Friday 25 December 2020 and Friday 1 January 2021;
- (e) the area coloured light blue and labelled H5 on the Akrotiri TGR map—
 - (i) on 23 August 2020;
 - (ii) from 30 August 2020 to 30 October 2020 (both dates included);
 - (iii) all Mondays, Tuesdays, Thursdays, Fridays and Saturdays from 2 November 2020 to 26 February 2021 (both dates included), except Friday 25 December 2020 and Friday 1 January 2021;
- (f) the area coloured light blue on the Dhekelia TGR map—
 - (i) from 1 October 2020 to 30 October 2020 (both dates included);
 - (ii) all Mondays, Tuesdays, Thursdays, Fridays and Saturdays from 2 November 2020 to 29 December 2020 (both dates included), except Friday 25 December 2020.

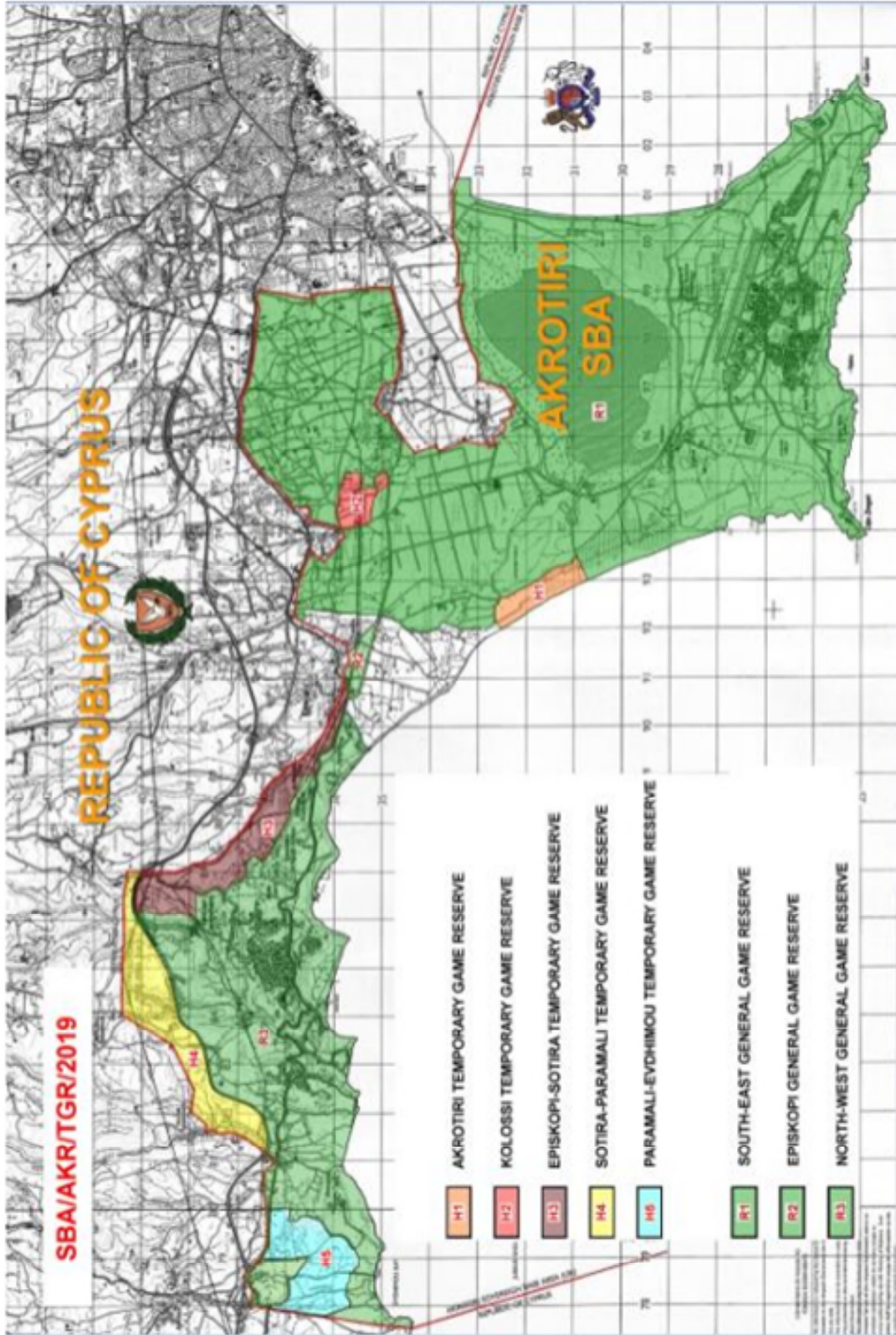

Article 2(a)

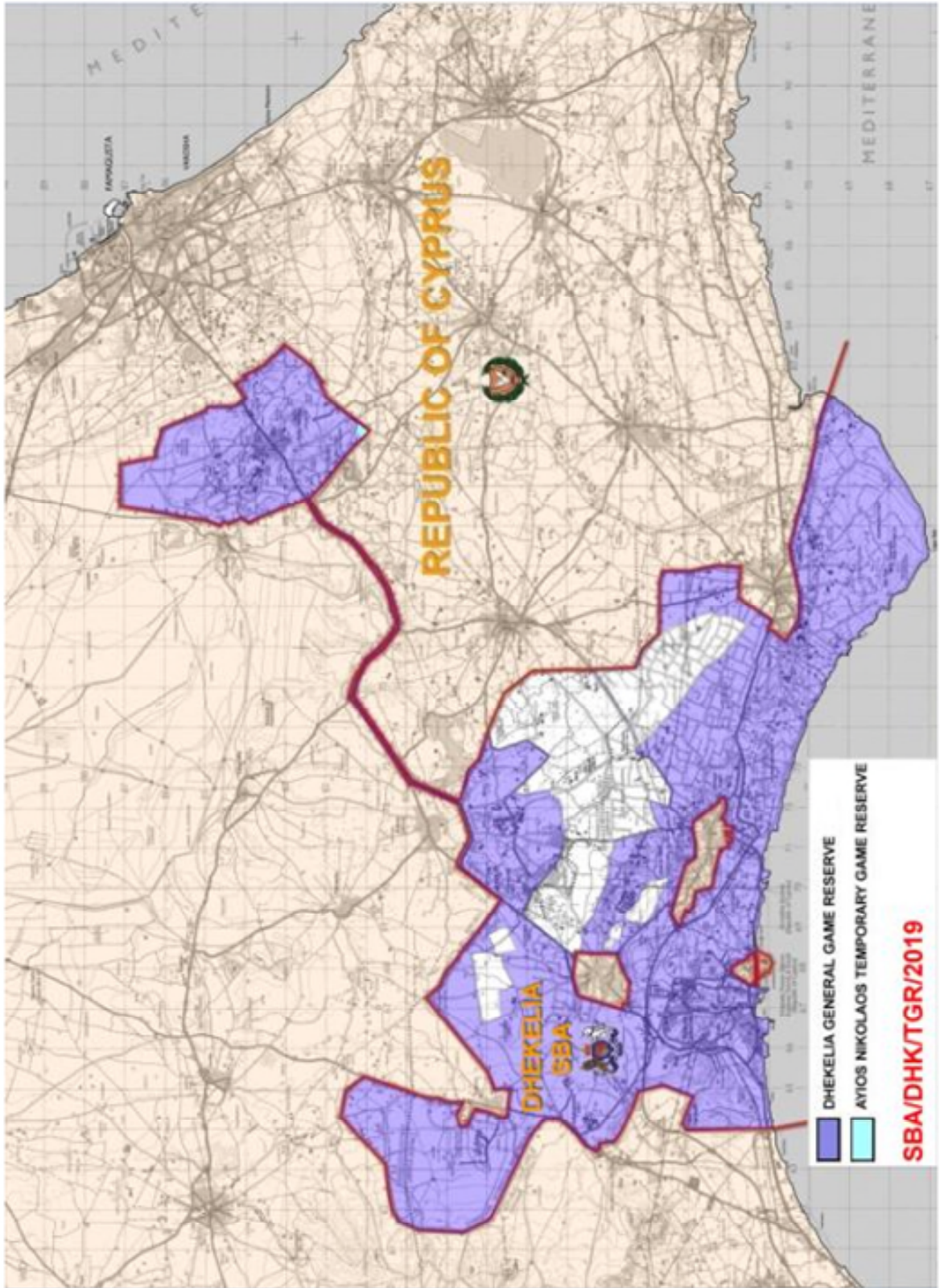
Akrotiri TGR map

EXPLANATORY NOTE

(This note is not part of the Order)

1. This explanatory note relates to the Game and Wild Birds (Temporary Game reserves) Order 2020 (the “Order”). It has been prepared by the Office of the Attorney General and Legal Adviser in order to assist the reader of the Order, and does not form part of the Order.

2. The Order designates areas as temporary game reserves under the Game and Wild Birds Ordinance 2008 (the “2008 Ordinance”) in the Akrotiri and Dhekelia Sovereign Base Areas. Temporary game reserves are areas which have not been designated as general game reserves under the Game and Wild Birds (General Game Reserves) Order 2019, but where hunting is prohibited during a game season on the dates prescribed in the Order.

3. The map showing the location of the temporary game reserves in the Akrotiri SBA is available for inspection by the public in the Akrotiri Area Office during normal working hours. That map also shows the location of the general game reserves in the Akrotiri SBA, as designated by the Game and Wild Birds (General Game Reserves) Order 2019. The map showing the location of the temporary game reserves in the Dhekelia SBA is available for inspection by the public at the Dhekelia Area Office. That map also shows the location of the general game reserve in the Dhekelia SBA.
