THE QUARANTINE (PUBLIC HEALTH)(AMENDMENT) REGULATIONS 2021

The Administrator makes the following Regulations in exercise of the power under section 6 of the Quarantine Ordinance(**a**).

Short title and commencement

1.—(1) These Regulations may be cited as the Quarantine (Public Health) (Amendment) Regulations 2021.

(2) These Regulations come into force on 29 May 2021.

Amendment of the Quarantine (Public Health) Regulations

2.—(1) The Quarantine (Public Health) Regulations(**b**) is amended as follows.

(2) In regulation 12 for "No person shall," substitute "Subject to regulation 12A, no person shall,".

(3) After regulation 12 insert—

"12A.—(1) The following persons shall be permitted to enter an isolation station on 30 May 2021, for the purpose specified in paragraph (2)—

- (a) persons authorised by the Elections Commissioner of the Republic,
- (b) police officers.

(2) The purpose specified in this paragraph is the facilitation of the exercise by any person suffering or suspected to be suffering from a dangerous infectious disease isolated in

the station of their right to participate in the elections to be held on that day under the Election of Members of the House of Representatives Laws of 1979 to 2021 of the Republic.".

EXPLANATORY NOTE

(This note is not part of the Regulations)

- **1.** This explanatory note relates to the Quarantine (Public Health) (Amendment) Regulations 2021.
- 2. The amendments are intended to mirror certain provisions of the Quarantine (Determination of Measures for the Prevention of the Spread of Corona Virus Covid-19) Order (No.19) of 2021 (P.I. 226/2021) of the Republic.
- **3.** Regulation 2 amends the Quarantine (Public Health) Regulations, so that a person authorised by Elections Commissioner of the Republic or the police of the Sovereign Base Areas may enter an isolation station for the purpose of allowing any persons in that isolation station to participate in the parliamentary elections in the Republic of Cyprus on 30 May 2021.
