**POLICE (LARNACA TO FAMAGUSTA MAIN  
ROAD) (TRAFFIC PROHIBITION) ORDER (NO. 2)  
2021**

The Administrator makes the following Order in exercise of the power under section 24(4) of the Police Ordinance (a).

**Citation and commencement**

1.—(1) This Order may be cited as the Police (Larnaca to Famagusta Main Road) (Traffic Prohibition) Order (No.2) 2021.

(2) This Order comes into force on 12 June 2021.

**Road Closure**

2.—(1) Subject to subsection (2), all traffic is prohibited at all times from using the part of the Larnaca to Famagusta Road Main road between the position latitude 35.061394° N, longitude 33.802260° E and the position latitude 35.061816° N, longitude 33.838658° E.

(2) Subsection (1) does not apply to vehicles and persons accessing the road for the purposes of the structural repairs being carried out on Ayios Nikolaos bridge at the position latitude 35.071609° N, longitude 33.822098° E.

3. This Order expires on 12 July 2021.

## **EXPLANATORY NOTE**

*(This note is not part of the Order)*

**1.** This explanatory note relates to the Police (Famagusta to Larnaca Main Road)(Traffic Prohibition) Order (No.2) 2021 (“the Order”). It has been prepared by the office of the Attorney General and Legal Adviser in order to assist the reader of the Order. It does not form part of the Order.

**2.** This note should be read in conjunction with the Order. It is not, and is not meant to be, a comprehensive description of the Order.

**3.** This Order is made under section 24(4) of the Police Ordinance 2007, which permits the Administrator to make an order prohibiting traffic from using a road for such period of time as may be specified in the order.

**4.** This Order prohibits traffic from using a section of the main road between Famagusta and Larnaca, known as Corridor Road, during construction works being carried out on Ayios Nikolaos bridge. Vehicles and persons involved in the construction works are permitted to continue to use the road.

**5.** The Order remains in force until 00:01 on 12 July 2021 when it is anticipated the works will have been completed.

**6.** A person who contravenes the Order commits an offence and is liable on conviction to a term of imprisonment of up to 6 months or a fine of €768, or both.
