
**LAND ACQUISITION (SECONDARY ROAD AT
KATO POLEMIDIA) ORDER 2021**

The Administrator makes the following Order in exercise of the powers in section 7 of the Land Acquisition Ordinance (a).

Citation and commencement

1. This Order may be cited as the Land Acquisition (Secondary Road at Kato Polemidia) Order 2021 and comes into force on the day after the day it is published in the Gazette.

Sanction of acquisition

2. This Order applies to the land listed on the Schedule and shown shaded red on a plan labelled SBA/AOA/KPM/CASRN/2020 which is available for inspection at the Area Office Akrotiri during normal working hours.

Sanction of acquisition

3. The Administrator sanctions the acquisition of the land referred to at paragraph 2 above.

EXPLANATORY NOTE

(This note is not part of the Order)

1. This explanatory note relates to the Land Acquisition (Secondary Road at Kato Polemidia) Order 2021 (the “Order”). It has been prepared by the Office of the Attorney General and Legal Adviser in order to assist the reader of the Order.
2. The Order is made under the Land Acquisition Ordinance (Cap.226) (the “Ordinance”), which sets out the statutory framework for the compulsory acquisition of land required for an “undertaking of public utility”.
3. The Order relates the compulsory acquisition of land required for the construction of a secondary road network in Kato Polemidia municipality, connecting the old road between Limassol and Paphos with Trachoni community and Zakaki quarter in Limassol municipality in the Republic.
