The Chief Officer makes the following Order in exercise of the power under section 3 of the Sewerage Ordinance 2008^(a).

Citation and commencement

1. This Order may be cited as Sewerage (Recognised Board) Order 2021 and comes into force on the day after the day on which it is published in the Gazette.

Declaration of recognised Board

2. The Sewerage Board of Limassol – Amathus may exercise powers and perform duties in the parts of the Akrotiri Sovereign Base Area identified in the Schedule by references to the official Republic of Cyprus Government survey plans.

EXPLANATORY NOTE

(This note is not part of the Order)

1. This explanatory note relates to the Sewerage (Recognised Board) Order 2021 (“the Order”). It has been prepared by the Office of the Attorney General and Legal Adviser in order to assist the reader of the Order. It does not form part of the Order.
2. Section 3 of the Sewerage Ordinance 2008 (“the Ordinance”) provides that the Chief Officer may by Order declare that a sewerage board established under the Republican law may exercise powers and perform duties in a specified part of the areas in accordance with section 4 of the Ordinance. A board exercising functions in the Areas under section 3 is known as a recognised Board.
3. The recognised Board declared in the Order is the Sewerage board of Limassol – Amathus which was established in the Republic by publication of Public Instrument 248/ 1980 in Official Gazette number 1627 of the Republic of 5th September 1980.
4. The specified parts of the Areas are set out in the Schedule and the references are to the official Republic of Cyprus Government survey plans.
