
SEA BATHERS (PROTECTION) (SEA BATHING AREAS) (AMENDMENT) ORDER 2022

The Chief Officer makes this Order in exercise of the powers conferred by section 4 of the Sea Bathers (Protection) Ordinance 2014(a).

Citation

1. This Order may be cited as the Sea Bathers (Protection) (Sea Bathing Areas) (Amendment) Order 2022.

Commencement

2. This Order comes into force on 29 April 2022.

Amendment of the Sea Bathers (Protection) (Sea Bathing Areas) Order 2014

3.—(1) The Schedule (descriptions of parts of the sea – sea bathing areas) to the Sea Bathers (Protection) (Sea Bathing Areas) Order 2014(b) is amended as follows.

(2) In Part 1 (Akrotiri Sovereign Base Area), for paragraph 8 (Lady’s Mile Beach), substitute—

“8. Lady’s Mile Beach—

- (a) the line joining the position latitude 34°38.429’N, longitude 33°00.667’E (“point A”) to the position latitude 34°38.429’N, longitude 33°00.731’E (“point B”),
- (b) the line joining point B to the position latitude 34°35.987’N, longitude 33°00.512’E (“point C”),
- (c) the line joining point C to the position latitude 34°35.991’N, longitude 33°00.475’E (“point D”),
- (d) the line joining point A to position point D, and
- (e) the waters inshore from, and perpendicular to, the line joining point A to point D, to the waterline.”

EXPLANATORY NOTE

(This note is not part of the Order)

1. This explanatory note relates to the Sea Bathers (Protection) (Sea Bathing Areas) (Amendment) Order 2022 (the “Order”). It has been prepared by the Office of the Attorney General and Legal Adviser in order to assist the reader of the Order. It does not form part of the Order. It is not intended to be a comprehensive description.

2. The Order is made by the Chief Officer under the Sea Bathers (Protection) Ordinance 2014, which confers powers to specify sea bathing areas that are reserved for the use of sea bathers for a specified period each year.

3. Article 3 of the Order amends the coordinates of the sea bathing area at Lady’s Mile Beach set out in the Schedule to the Sea Bathers (Protection) (Sea Bathing Areas) Order 2014.
