**LAND ACQUISITION (PUMPING STATION AND  
ACCESS ROAD AT ORMIDHIA VILLAGE) ORDER

The Administrator makes the following Order in exercise of the power under section 7 of the Land Acquisition Ordinance (a).

**Citation and Commencement**

1. This Order may be cited as the Land Acquisition (Pumping Station and Access Road at Ormidhia Village) Order 2022 and comes into force the day after it is published in the Gazette.

**Territorial extent**

2. The Order applies to the land listed in the Schedule and shown coloured red and yellow on a plan labelled SBA/AOD/PS/AR/KSS/ORM/2021 which is available for inspection at the Area Office Dhekelia during normal working hours.

**Sanction of Acquisition**

3. The Administrator sanctions the acquisition of the land referred to at paragraph 2 above.

## **EXPLANATORY NOTE**

*(This note is not part of the Regulations)*

1. This explanatory note relates to the Land Acquisition (Pumping Station and Access Road) Order 2022 (the “Order”). It has been prepared by the Office of the Attorney General and Legal Adviser in order to assist the reader of the Order.

2. The Order is made under the Land Acquisition Ordinance (Cap. 226) (the “Ordinance”), which sets out the statutory framework for the compulsory acquisition of land required for an “undertaking of public utility”.

3. The Order relates to the compulsory acquisition of land required for the construction of a pumping station and access road at Ormidhia Village, as part of the wider Kokkinochoria Sewage Project, in an undertaking of public utility for the purpose of s.2 of the Land Acquisition Ordinance.
