**SOVEREIGN BASE AREAS OF AKROTIRI AND  
DHEKELIA**

**The Sovereign Base Areas of Akrotiri and Dhekelia (Boundaries)  
Order in Council, 1962**

*Made - - - - 26th February, 1962*  
*Coming into Operation 12th March, 1962*

At the Court at Buckingham Palace, the 26th day of February, 1962

**Present,**

The Queen's Most Excellent Majesty in Council

Her Majesty, by virtue and in exercise of the powers in that behalf by subsection (3) of section 2 of the Cyprus Act, 1960(a), or otherwise in Her Majesty vested, is pleased, by and with the advice of Her Privy Council, to declare and order, and it is hereby declared and ordered as follows—

**1. Arrangements have been made—**

(a) for the demarcation of the boundaries of the areas referred to in subsection (1) of section 2 of the Cyprus Act, 1960, that is to say the Sovereign Base Areas of Akrotiri and Dhekelia, by two Commissioners appointed by the Government of the United Kingdom of Great Britain and Northern Ireland and two Commissioners appointed by the Government of the Republic of Cyprus as specified in the arrangements ;

(b) for the determination, in default of agreement between the Commissioners, of any question as to the interpretation of the maps, photographs or descriptive matter ; and

(c) for the variation of the boundaries, as defined by the maps, photographs and descriptive matter, by agreement between the Commissioners on its appearing to them expedient to do so on any grounds specified in the arrangements.

2. The Commissioners have, by their report dated 5th December, 1961, reported that the said boundaries have been demarcated in accordance with the arrangements.

3. The twelfth day of March, 1962, shall be the date as from which the boundaries of the said Sovereign Base Areas of Akrotiri and Dhekelia shall be the boundaries so demarcated by the Commissioners.

4. This Order may be cited as the Sovereign Base Areas of Akrotiri and Dhekelia (Boundaries) Order in Council, 1962, and shall come into operation on the twelfth day of March, 1962.

#### EXPLANATORY NOTE

*(This Note is not part of the Order, but is intended to indicate its general purport.)*

Under this Order as from 12th March, 1962, the boundaries of the Sovereign Base Areas of Akrotiri and Dhekelia will be the boundaries that have been demarcated by the Commissioners appointed by the Government of the United Kingdom and the Government of the Republic of Cyprus.
