NOTICE UNDER SECTION 16(3) OF THE SEASHORE
PROTECTION ORDINANCE 2013

By way of this Notice, the Area Officer, Dhekelia, acting in accordance with section 16(3) of the Seashore Protection Ordinance 2013, notifies those interested parties of the draft plan prepared by the Ormidhia seashore committee, which replaces the plan approved by the Administrative Secretary and published in the Gazette on 28 March 2013.

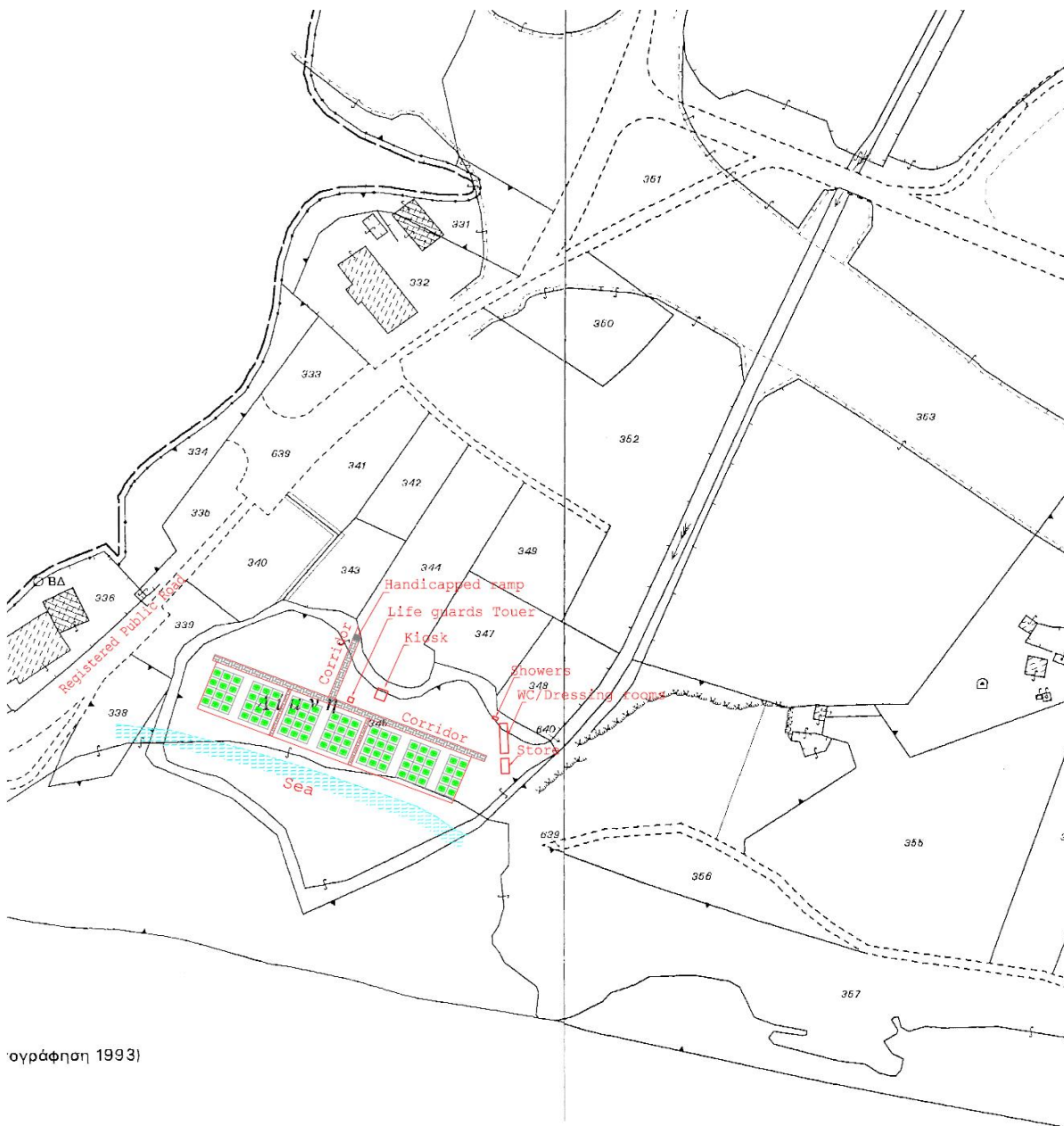
The draft plan shows the part of the seashore, being Crown (hali) land, in the area administered by the Ormidhia Community Council where the Ormidhia Community Council are proposing that the following (shown in red and green) will be provided for use by the public:-

- 160 sun beds and 80 umbrellas;
- a movable kiosk covering an area of 12 square metres used for the sale of snacks and refreshments;
- a movable storage facility for the storage of sun bed mattresses, umbrellas and other paraphernalia belonging to the Ormidhia Community Council covering an area of 18 square metres;
- a movable structure to be used as toilets and dressing rooms covering an area of 36 square metres;
- 2 movable showers;
- a movable structure to be used as a lifeguard tower.

The draft plan attached to the Notice is also available for inspection at the Area Office Dhekelia during normal office hours.

An interested person wishing to make representations to the Administrator concerning the plan may do so by writing to the Sovereign Base Areas Headquarters, Sovereign Base Areas Administration, Episkopi, British Forces Post Office 53 or writing to the Area Office, Dhekelia, British Forces Post Office 58.

Any representations must be submitted by 12 July 2015.
