UK Legislation applicable to the Sovereign Base Areas

[The Emergency Powers \(Overseas Territories\) Order 2017](#)

The Emergency Powers (Overseas Territories) Order 2017 (SI 181) will come into force on 16th March 2017.

This Order enables the Administrator of the Sovereign Base Areas, to proclaim a public emergency and to make regulations for specified purposes during that emergency. The Order revokes and replaces the Emergency Powers Order in Council 1939 and its amending Orders, as well as the Leeward Islands (Emergency Powers) Order in Council 1959, the provisions of which this Order consolidates and updates.

[The Terrorist Asset-Freezing etc. Act 2010 \(Overseas Territories\) \(Amendment\) Order 2017](#)

The Terrorist Asset-Freezing etc. Act 2010 (Overseas Territories) (Amendment) Order 2017 comes into force on 8th March 2017.

This Order amends the Terrorist Asset-Freezing etc. Act 2010 (Overseas Territories) Order 2011 (S.I. 2011/750) (as amended) (“the principal Order”).
