### [The Democratic People's Republic of Korea \(Sanctions\) \(Overseas Territories\) Order 2020](#)

The Democratic People's Republic of Korea (Sanctions) (Overseas Territories) Order 2020, comes into force immediately after both the Sanctions (EU Exit) (Miscellaneous Amendments) Regulations 2020 and the Sanctions (EU Exit) (Miscellaneous Amendments) (No.3) Regulations 2020 have come into force in the United Kingdom.

This Order extends with modifications the Democratic People's Republic of Korea (Sanctions) (EU Exit) Regulations 2019 (S.I. 2019/411) ("the DPRK Regulations") as amended from time to time to all British overseas territories except Bermuda and Gibraltar (which implement sanctions under their own legislative arrangements).

### [The Yemen \(Sanctions\) \(Overseas Territories\) Order 2020](#)

The Yemen (Sanctions) (Overseas Territories) Order 2020, comes into force immediately after IP completion day.

This Order extends with modifications the Yemen (Sanctions) (EU Exit) (No. 2) Regulations 2020 (S.I. 2020/1278) ("the Yemen Regulations") as amended from time to time to all British overseas territories except Bermuda and Gibraltar (which implement sanctions under their own legislative arrangements). It also implements in those territories the travel ban in respect of UN designated persons required by paragraph 15 of resolution 2140 (2014) adopted by the Security Council on 26 February 2014 (which in the United Kingdom is implemented by way of the Immigration Act 1971 (c.77) rather than the Yemen Regulations).

### [The Republic of Guinea-Bissau \(Sanctions\) \(Overseas Territories\) Order 2020](#)

The Republic of Guinea-Bissau (Sanctions) (Overseas Territories) Order 2020, comes into force immediately after both the Sanctions (EU Exit) (Miscellaneous Amendments) (No. 2) Regulations 2020 and the Sanctions (EU Exit) (Miscellaneous Amendments) (No. 4) Regulations 2020 have come into force in the United Kingdom.

This Order extends with modifications the Republic of Guinea-Bissau (Sanctions) (EU Exit) Regulations 2019 (S.I. 2019/554) ("the Guinea-Bissau Regulations") as amended from time to time to all British overseas territories except Bermuda and Gibraltar (which implement sanctions under their own legislative arrangements). It also implements in those territories the travel ban in respect of UN designated persons required by paragraph 4 of resolution 2048 (2012) adopted by the Security Council on 18 May 2012 (which in the United Kingdom is implemented by way of the Immigration Act 1971 (c.77) rather than the Guinea-Bissau Regulations).

### The Mali (Sanctions) (Overseas Territories) Order 2020

The Mali (Sanctions) (Overseas Territories) Order 2020, comes into force immediately after the Sanctions (EU Exit) (Miscellaneous Amendments) (No. 5) Regulations 2020 have come into force in the United Kingdom.

This Order extends with modifications the Mali (Sanctions) (EU Exit) Regulations 2020 (S.I. 2020/705) (“the Mali Regulations”) as amended from time to time to all British overseas territories except Bermuda and Gibraltar (which implement sanctions under their own legislative arrangements). It also implements in those territories the travel ban in respect of UN designated persons required by paragraph 1 of resolution 2374 (2017) adopted by the Security Council on 5<sup>th</sup> September 2017 (which in the United Kingdom is implemented by way of the Immigration Act 1971 (c.77) rather than the Mali Regulations).

### The Sanctions (Overseas Territories) (Revocations) Order 2020

The Sanctions (Overseas Territories) (Revocations) Order 2020 comes into force as follows—

- (a) article 2(1) and Schedule 1 come into force immediately after—
  - (i) the Sanctions (EU Exit) (Miscellaneous Amendments) Regulations 2020,
  - (ii) the Sanctions (EU Exit) (Miscellaneous Amendments) (No. 2) Regulations 2020,
  - (iii) the Sanctions (EU Exit) (Miscellaneous Amendments) (No. 3) Regulations 2020,
  - (iv) the Sanctions (EU Exit) (Miscellaneous Amendments) (No. 4) Regulations 2020,
  - (v) the Sanctions (EU Exit) (Consequential Provisions) (Amendment) Regulations 2020, and
  - (vi) the Sanctions (EU Exit) (Miscellaneous Amendments) (No. 5) Regulations 2020 have come into force in the United Kingdom;

(b) all other articles and Schedule 2 come into force on IP completion day. This Order revokes Orders in Council which gave effect in specified British overseas territories to various sanctions regimes established during the United Kingdom’s membership of the European Union or during the Transition Period (“sanctions orders”).

### The United Nations Sanctions (Revocations) Order 2020

The United Nations Sanctions (Revocations) Order 2020, comes into force as follows—

- (a) in the United Kingdom, the Bailiwick of Guernsey, the Isle of Man and the British overseas territories listed in Schedule 1 to this Order, on IP completion day;
- (b) in the Bailiwick of Jersey, on the day following the day on which it is registered by the Royal Court of Jersey or on IP completion day, whichever is the later.

This Order revokes a number of instruments made under the United Nations Act 1946 (c.45) implementing United Nations sanctions, which are no longer required.

The ISIL (Da'esh) and Al-Qaida (United Nations Sanctions) (Overseas Territories) Order 2020 comes into force immediately after—

- (a) the Sanctions (EU Exit) (Miscellaneous Amendments) Regulations 2020,
- (b) the Sanctions (EU Exit) (Miscellaneous Amendments) (No. 3) Regulations 2020, and
- (c) the Sanctions (EU Exit) (Consequential Provisions) (Amendment) Regulations 2020, have come into force in the United Kingdom.

This Order extends with modifications the ISIL (Da'esh) and Al-Qaida (United Nations Sanctions) (EU Exit) Regulations 2019 (S.I. 2019/466) (“the Regulations”) as amended from time to time to all British overseas territories except Bermuda and Gibraltar (which implement sanctions under their own legislative arrangements).
