NOTICE OF ACQUISITION
Under section 6(1) of the Land Acquisition Ordinance (CAP. 226)

NOTICE is hereby given that the private immovable property described in the Schedule and having a total area of approximately 1733 square metres, is required for an undertaking of public utility, namely the construction of a Pumping Station and Access Road, at Ormidhia village and will connect the community of Ormidhia with the Kokkinochoria Sewerage System.

Any person claiming to have any right or interest in the said immovable property, who objects to its acquisition, is required, within 30 days from the date of publication of this notice, to send me a statement of his right and interest and of the evidence thereof, and of any claim made by him, in respect of such right or interest.

The Administrator of the Sovereign Base Areas is willing to treat for the acquisition of the said immovable property.
