Under section 6(1) of the Land Acquisition Ordinance (CAP. 226)

NOTICE is hereby given that the private immovable property described in the Schedule and having a total area of approximately 448 square metres, is required for an undertaking of public utility, namely the construction of a Pumping Station, at Avgorou village and will connect the community of Avgorou with the Kokkinochoria Sewerage System.
