**CRIMINAL PROCEDURE ORDINANCE 2016
AUTHORISATION UNDER SECTION 11(2)**

RENEWAL OF AUTHORISATION TO ACT AS INVESTIGATING OFFICER

You are currently listed in the table in Enclosure A below as a person authorised under section 11(2) of the Criminal Procedure Ordinance 2016 to investigate the commission of the offences specified in your original letter of authorisation.

In accordance with that section, I hereby renew your authorisation in relation to the same offences as specified in your original letter of authorisation.
